Pursuant to R8-63(e)(4) and R8-66(h) of the North Carolina Utilities Commission (“Commission”) Rules and Regulations, Oak Trail Solar, LLC (“Oak Trail”) submits this letter to notify the Commission that the internal change of control described in the March 9, 2021 filing in the above-referenced docket occurred on March 26, 2021. First Solar Development, LLC, an indirect wholly-owned subsidiary of First Solar, Inc. (“FSI”) transferred 100% of the direct ownership interests in Oak Trail to FS Saguaro, LLC (“Saguaro”), an indirect wholly-owned subsidiary of FSI. Oak Trail remains a wholly owned indirect subsidiary of FSI.

Further notice is hereby being provided of another pending change in control in Oak Trail. It is anticipated that on March 31, 2021, Leeward Renewable Energy Development, LLC (“Leeward”) will acquire 100% of the membership interests in Saguaro through a Purchase and Sale Agreement (“PSA”). Upon closing of the PSA, Leeward will be the indirect upstream owner of Oak Trail. The parties to the PSA will provide any further required updates upon closing.

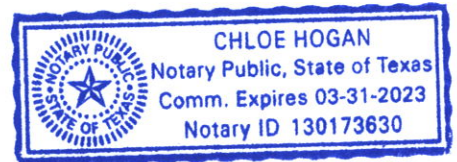
