BY THE PRESIDING COMMISSIONER: On January 17, 2020, the Commission issued an Order Approving DSM/EE Rider and Requiring Filing of Proposed Customer Notice (DSM/EE Order) in the above-captioned docket. In summary, the DSM/EE Order approved the application of Virginia Electric and Power Company d/b/a Dominion Energy North Carolina (DENC) for rate Riders C and CE to allow DENC to recover costs and incentives for providing demand-side management and energy efficiency (DSM/EE) programs to its customers.

On Feb 11, 2020, the Public Staff filed a letter informing the Commission of an inadvertent error in the DSM/EE Order. The Public Staff stated that Ordering Paragraph No. 2 of the DSM/EE Order incorrectly references the amounts for Rider CE as decrement billing factors. The Rider CE billing factors are in fact increments, as stated in DENC's application, the Public Staff's testimony, and Finding of Fact No. 12 in the DSM/EE Order. The Public Staff represented that DENC agrees that the DSM/EE Order should reference the Rider CE billing factors as increments and not decrements. Accordingly, the Public Staff, on behalf of itself and on behalf of DENC, requested that the Commission correct the DSM/EE Order to note the billing factors as increments.

Based on the foregoing and the record, the Presiding Commissioner finds good cause to amend Ordering Paragraph No. 2 of the DSM/EE Order to change the word "decrement" to "increment," as follows:

2. That the appropriate annual DSM/EE EMF rider, Rider CE, to become effective on and after February 1, 2020, consists of the following customer class increment billing factors (including Regulatory Fee): Residential – 0.016 ¢/kWh; Small General Service and Public Authority – 0.018 ¢/kWh; Large General Service – 0.011 ¢/kWh; and no decrement for 6VP, NS, Outdoor Lighting and Traffic Lighting.

IT IS, THEREFORE, SO ORDERED.
