

Subj: Request for Information, via -Freedom of Information Act, (FOIA)

Dear Commissioner Clodfelter,

- 1. Reference (d), reply by General Counsel Sam Watson is unsatisfactory. He did not respond to request. (What is the authorization used to put Exhibit No. 2 into Record?) His vague reply; -that any potentially responsive documents is in NCUC Docket Portal points that Exhibit No. 2 is New Evidence and subject to G.S. 62-65 and G.S. 62-70; from his reply, to be pursued as New Evidence entered into Record without authorization, (as -there is no audit trail authorizing entry that I can find):
- 2. Background information is stated below to help identify requested information:
- a. Duke Energy Progress (DPE) submitted two Late-Filed Exhibits of 13 Nov. 2018, for the Record, to the Commission, shown in reference (b). (Enclosure (1) is cover letter and Exhibit No. 2.)
- 1) Exhibit No. 1 is information pertaining to a 230kV line running parallel with a 500kV line. Shown authorized in Transcript record; reference (c) pages: -154/159 10822 24; 155/159 10821 24; 156/159 10821 24; 156/159 10821 24; stated at Hearing, reference (c), and was expected as a Late-Filed Exhibit after Hearing 31 Oct. 2017.
- 2) Exhibit No. 2 is A cost comparison of the four best-scored alternative routes; it is titled

at top of page as: Cost Comparison of Routes 31, 4, 32, and 1; top, right side, labeled as DEP LATE FILED EXHIBIT NO. 2 DOCKET NO. E2, SUB 1150; shown in reference (b) and enclosure (1).

-This Exhibit No. 2 is not authorized via Transcript, reference (c). It is unknown to me what-happened between 31 Oct. 2017, after Hearing, ... 13 Nov. 2017 date of enclosure (1). The Record shows Exhibit No. 2 was scanned-dated into Record on 13 Nov. 2017 with/under cover letter -same date. The Commission's" Order" of 12 Jan. 2018 used this information to grant "Order" and Certificate for construction of 230kV Transmission Line; (thus, purpose of this FOIA request In Accordance With N.C. G.S. 132-1, reference (a)).

- 3. In accordance with reference (a), -Request authorization or source document, copy, used to admit Exhibit No. 2 into the Record.
- 4. If there are fees for searching or copying requested information, please inform me if the cost exceeds \$5.00. However, I would also like to request a waiver of all fees in that the disclosure of the requested information is in the public interest and will contribute significantly to the public's understanding of Duke Energy's rate hikes. I am Intervener for Docket No. E-2, Sub 1150, this requested information will help in clarifying some of Duke Energy's rate hikes.
- 5. The law requires that you respond to and fulfill this request "as promptly as possible." If you expect a significant delay in responding to and fulfilling this request, please contact me with information about when I might expect copies or the ability to inspect the required records. (no phone, use U.S. Mail).
- 6. If you deny any or all this request please site each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law.
