Pursuant to North Carolina General Statutes (“N.C. Gen. Stat.”) §§ 62-60 and 84-4.1 and Rule R1-22 of the North Carolina Utilities Commission (the “Commission”) Rules of Practice and Procedure, Melissa Oellerich Butler of Troutman Pepper Hamilton Sanders LLP respectfully requests the Commission to enter an order permitting her to practice *pro hac vice* before the Commission on behalf of Duke Energy Carolinas, LLC (the “Company”) in the above-captioned matter.

In support of this motion, Ms. Butler alleges and shows the following:

1. The above-captioned matter is a regulatory proceeding before the Commission governed by North Carolina public utility law.
2. The Company is a limited liability company, duly organized and existing under the laws of the State of North Carolina and is a public utility under the laws of North Carolina with operations subject to the jurisdiction of this Commission.
3. Ms. Butler is an attorney in good standing, licensed to practice law in the State of Florida, State of Georgia, and State of South Carolina and will appear on behalf of the Company in the above-captioned proceeding.

5. Ms. Butler will, unless permitted to withdraw sooner by order of the Commission, continue to represent the Company in the above-captioned proceeding until the final determination thereof.

6. Ms. Butler has agreed to be subject to the orders and is amenable to the disciplinary action and civil jurisdiction of the General Court of Justice and the North Carolina State Bar in all respects as if she were a regularly admitted and licensed member of the Bar of North Carolina in good standing.

7. The Bars of Florida, Georgia and South Carolina in which Ms. Butler is regularly admitted to practice, grant permission to members of the Bar of North Carolina in good standing to practice *pro hac vice* under circumstances similar to those authorized by N.C. Gen. Stat. § 84-4.1.

8. Ms. Butler, who is counsel for the Company, is associated for purposes of appearing before the Commission with Jack E. Jirak of Duke Energy, a resident of this state who is duly and legally permitted to practice in the General Court of Justice of North Carolina, upon which service may be had in all matters connected with the legal proceeding, or any disciplinary matter, with the same effect as if personally made on Ms. Butler.

9. Ms. Butler has not been disciplined by any court or lawyer regulatory organization, nor has she had *pro hac vice* privileges revoked.


10. The Statements required by N.C. Gen. Stat. § 84-4.1 are attached to this motion.



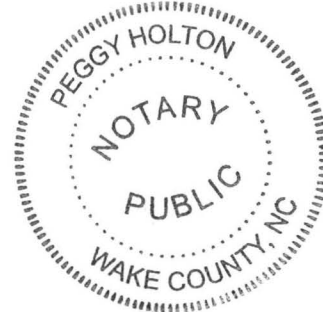


