2. The Public Staff plans to file a proposed order in this proceeding, but due to the press of business and the large number of other proceedings in which the Public Staff is involved, the Public Staff will not be able to file its proposed order on Monday, August 26, 2013.

WHEREFORE, the Public Staff prays:


1. For an extension of time until Monday, September 9, 2013, for all parties to file their proposed orders and briefs; and
