NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission, by and through its Executive Director, Christopher J. Ayers, and moves that the Commission issue an order granting a rate increase for Saxapahaw Utility Company and requiring customer notice. In support of this motion the Public Staff respectfully shows unto the Commission:

1. On October 18, 2021, Saxapahaw Utility Company (Saxapahaw) filed an Application with the Commission seeking authority to increase its rates for water utility service in the Village of Saxapahaw in Alamance County, North Carolina. By order issued November 15, 2021, the Commission declared the matter to be a general rate case and suspended the proposed rates. On December 22, 2021, the Commission entered an order scheduling a public witness hearing for February 15, 2022, subject to cancellation if no significant protests were received subsequent to customer notice. The December 22, 2021 order also scheduled an expert witness hearing on March 17, 2022.

- 2. Saxapahaw filed a Certificate of Service indicating customer notice had been given on January 27, 2022. No protests have been received.
- 3. On February 2, 2022, the Public Staff filed a motion to cancel the public witness hearing. By order issued February 7, 2022, the Commission canceled the hearing and directed Saxapahaw to notify its customers of the cancellation and provide proof that notice of the cancellation was provided to customers. P roof that notice of the cancellation of the public witness hearing was provided to customers was filed on March 3, 2022.
- 4. On February 21, 2022, the Public Staff filed the Affidavit of Darrell Brown, Financial Analyst with the Public Staff Accounting Division. The Affidavit of Lindsay Darden, Engineer with the Public Staff Water, Sewer, and Communications Division was filed on February 22, 2022. In these affidavits the witnesses' state they investigated the Application and found Saxapahaw's proposed rates to be reasonable. The witnesses recommend approval of the proposed rates, and they state Saxapahaw is providing adequate service to its customers.
- 5. Saxapahaw stated to the Public Staff it is in agreement with the Public Staff's recommendations and that it waives its right to file exceptions and requests the Commission approved rates be effective the date of the Commission Order.
 - 6. A proposed order is being filed with this motion.

WHEREFORE, the Public Staff prays:

1. That the Commission issue an order granting Saxapahaw a rate increase at the rates recommended by the Public Staff and requiring Saxapahaw to notify its customers of the rate increase; and

- 2. That the Commission cancel the March 17, 2022 evidentiary hearing; and
- 3. For such other and further relief as the Commission may deem just and proper.

PROPOSED ORDER
GRANTING RATE
INCREASE, CANCELLING
EVIDENTIARY HEARING
AND REQUIRING
CUSTOMER NOTICE

BY THE COMMISSION: This proceeding commenced October 18, 2021 with the filing of an Application for a rate increase by Saxapahaw Utility Company (hereafter, Saxapahaw, Applicant, or Company). On November 15, 2021 the Commission issued an order declaring this proceeding to be a general rate case and suspending the proposed rates for up to 270 days. On December 22, 2021, the Commission entered an order scheduling a public witness hearing for February 15, 2022. This hearing was made subject to cancellation if no significant customer protests were received by February 1, 2022. The December 22, 2021 order also scheduled an expert witness hearing for March 17, 2022. No protests to the proposed rate increase were received and the Public Staff filed a Motion to Cancel Hearing on February 2, 2022. The Commission received no response to the cancellation of the hearing. The Commission issued an Order cancelling the hearing and directing Saxapahaw to provide its customers with notice of the cancellation on February 7, 2022. The Certificate of Service – stating notice of the hearing cancellation had been sent to all customers was filed on March 3, 2022.

On February 21, 2022, the Public Staff filed an Affidavit for Public Staff witness

Darrell Brown – Financial Analyst with the Public Staff Accounting Division.

Public Staff witness Lindsay Darden, – Engineer with the Public Staff Water, Sewer, and Telephone Division Affidavit was filed on February 22, 2022.

A Motion for Order Granting Rate Increase and Requiring Customer Notice was filed by the Public Staff on March 3, 2022. A proposed order accompanied the Motion.

Based on the foregoing, and the entire record in this matter, the Commission makes the following

FINDINGS OF FACT

- Saxapahaw is properly before the Commission seeking an increase in its rates and charges for water utility service;
- 2. The test year established for use in this proceeding is the 12-month period ending December 31, 2020;
- Saxapahaw provides water service to approximately 144 residential and commercial connections. Four of the residential connections are for a condominium complex with 72 residential units;
- 4. Saxapahaw's present and proposed rates are as follows:

5. The original cost rate base for use in this proceeding is \$271,387, consisting of plant in service of \$940,676 plus working capital of \$15,458, less accumulated

- depreciation & amortization of \$388,630, contributions in aid of construction of \$295,892, and average tax accruals of \$225;
- 6. The appropriate level of total annual water revenues for use in this proceeding is \$150,116 under Saxapahaw's present rates, and \$159,152 under the proposed rates;
- 7. For purposes of this proceeding the appropriate cost of service (i.e., deductible operating & maintenance expenses) is \$151,004. The level of operating revenue deductions requiring a return (total operating expenses excluding the regulatory fee and income taxes) is \$149,783.
- 8. The rate base method is the appropriate method for determining Saxapahaw's revenue requirement for water operations in this proceeding;
- 9. The Public Staff's proposed rates will produce an overall rate of return of 3.55% on rate base. This return is not in excess of a reasonable level, and accordingly, the proposed rates are reasonable;
- 10. The rates proposed by Saxapahaw were agreed to by the Public Staff. These rates are:

WHEREUPON, the Commission reaches the following

CONCLUSIONS

Based upon the entire record in this proceeding, the Commission finds and concludes that the Applicant has sufficiently demonstrated the need to increase its rates for providing water utility service. The Commission, therefore, concludes that the rates proposed by the Public Staff, and agreed to by Saxapahaw, are just and reasonable and should be approved.

IT IS THEREFORE, ORDERED as follows:

- That Saxapahaw is authorized to increase its rates for water utility service in the Village of Saxapahaw as reflected in the Findings of Fact above. These rates shall be effective for service rendered on and after the date of this Order.
- That the Schedule of Rates included herein attached hereto as Appendix A is hereby approved and deemed filed with the Commission pursuant to N.C.G.S. § 62-138.
- 3. That the evidentiary hearing scheduled for March 17, 2022 be and hereby is cancelled.
- 4. That a copy of the Notice to Customers attached hereto as Appendix B shall be mailed or hand delivered to all customers of Saxapahaw within five days of the date of this Order, and that Saxapahaw shall submit to the Commission the attached Certificate of Service properly signed and notarized not later than March XX, 2022.
