Agreement to Extend Discovery Deadlines**

Dear Ms. Dunston:

I write to inform the Commission that Applicant Macadamia Solar LLC (“Applicant”) and the Public Staff have mutually agreed to alter, as between those two parties, certain discovery deadlines set by the Commission in the *Order Consolidating Dockets, Scheduling Hearings, Requiring Filing of Testimony, Establishing Procedural Guidelines, and Requiring Public Notice* issued on September 24, 2021 (the “Order”).

The Order provides that the direct testimony and exhibits of the Public Staff and other intervenors shall be filed on or before Tuesday, November 23, 2021; that formal discovery requests of the Public Staff or intervenors shall be served not later than three days after such testimony is filed; and that the party served shall have up to three calendar days to file with the Commission any objections to the discovery requests.

Because this schedule would result in discovery having to be conducted by both parties over the Thanksgiving Holidays, Applicant and the Public Staff have mutually agreed to a brief extension of that timeline, such that formal discovery requests of the Public Staff would be served by November 30, 2021, and objections to such discovery would be due by December 3. Applicant and the Public Staff acknowledge that intervenors, if any, in these consolidated dockets would not be subject to this extension absent their agreement or an Order of the Commission.
