ORDER CHANGING LOCATION OF HEARING

BY THE CHAIR: On January 30, 2001, the Commission issued an Order Changing Location of Hearing. The location was changed due to the Guilford County Department of Social Services rescinding permission to use their facility for the public hearing citing concerns for the security and protection of confidential materials at their site.

The Commission concludes that every effort should be made to inform the using and consuming public of the change in the hearing location site. To this end, public notice of the change in the hearing location should appear in newspapers of general circulation in the 336 area code territory.

IT IS, THEREFORE, ORDERED as follows:

1. As the local exchange companies with the largest serving areas, BellSouth Telecommunications, Inc. and North State Telephone Company shall assume primary responsibility for assuring, with the cooperation of the other local exchange companies (LECs) and telephone membership corporations (TMCs), the publication of the change in public hearing location notice, Appendix A. Such notice shall be published in newspapers of general circulation throughout the geographic territory covered by the 336 area code and shall cover not less than 1/4 of a page.

2. Such notice shall be published once a week for two successive weeks concluding by no later than February 27, 2001. Each LEC/TMC which publishes the attached public notice, shall not later than March 6, 2001, file affidavits regarding such newspaper publication and a list of papers used for publication and the dates the notice was published in each newspaper.
