Pursuant to the Securitization Statute, "[n]o later than 135 days after the date" the Companies file this Joint Petition, the Commission "shall issue a financing order or an order rejecting the [Joint Petition]." Prior to submittal of this Joint Petition, the Companies and the North Carolina Utilities Commission—Public Staff ("Public Staff") developed an agreed-upon schedule adhering to the procedural requirements prescribed by the Securitization Statute for Commission consideration. The proposed procedural schedule is as follows:
