Enclosed for filing is Fresh Air Energy XI, LLC's ("FAE XI") Registration as a New Renewable Facility for its Tick Bite PV1 solar facility (the "Facility") pursuant to Commission Rule R8-66.

Please note that Fresh Air Energy II, LLC ("FAE II") originally registered the Facility under Docket No. SP-2665, Sub 6 on 10/13/13. FAE II then requested a transfer of the Registration and associated Certificate of Public Convenience and Necessity ("CPCN") to FAE XI. The CPCN was, in fact, transferred to FAE XI under Docket No. SP-3557, Sub 0 on 5/30/14; however, FAE XI has since been informed by the Chief Clerk's Office that, while the CPCN was successfully transferred to the new docket, the R8-66 Registration was not, and that the R8-66 Registration should be re-filed. As such, FAE XI is re-filing the R8-66 Registration for the Facility under Docket No. SP-3557, Sub 0.

Fresh Air Energy XI ("FAE XI" or the "Applicant") hereby submits to the North Carolina Utilities Commission ("NCUC") a Registration as a New Renewable Energy Facility for its 5 MW-AC solar photovoltaic facility, informally known as Tick Bite PV1, located in Lenoir County, pursuant to G.S. § 62-133.8 and NCUC Rule R8-66.

REGISTRATION AS A NEW RENEWABLE ENERGY FACILITY

In support of its registration as a Renewable Energy Facility pursuant to R8-66, the Applicant states the following:

1. The Applicant incorporates, by reference, each of the foregoing information, in support of its registration as a New Renewable Energy Facility.

2. Duke Energy Progress will read the energy production meter for the purpose of REC issuance.

3. The Applicant anticipates participating in the North Carolina Renewable Energy Tracking System.

4. The Applicant certifies that it is in substantial compliance with all federal and state laws, regulations, and rules for the protection of the environment and conservation of natural resources.

5. The Applicant certifies that the facility satisfies the requirements of G.S. § 62-133.8(a)(5) as a new renewable energy facility and will continue to be operated as a new renewable energy facility.

6. The Applicant certifies that any renewable energy certificates (whether or not bundled with electric power) sold to an electric supplier to comply with G.S. § 62-133.8 neither have been nor will be remarketed or otherwise resold for any other purpose, including another renewable energy portfolio standard or voluntary purchase of renewable energy certificates in North Carolina or any other state or country, and that the electric power associated with the certificates will not be offered or sold with any representation that the power is bundled with renewable energy certificates.

7. The Applicant certifies that it consents to the auditing of its books and records by the Public Staff insofar as those records relate to transactions with North Carolina electric suppliers, and agrees to provide the Public Staff and Commission access to those books and records, wherever they are located, and access to the facility.

WHEREFORE, Fresh Air Energy XI, LLC respectfully requests that the Commission:

- Jun 15 2017
- (i) Accept the Registration of the Facility as a New Renewable Energy Facility pursuant to G.S. § 62-133.8 and Commission Rule R8-66.
- (ii) Rescind the Registration accepted under Docket No. SP-2665, Sub 6, which is the docket that the Facility was originally registered under.
