NOTICE IS HEREBY GIVEN that on February 27, 2015, Red Cedar Solar, LLC (Applicant), filed an application seeking a certificate of public convenience and necessity pursuant to G.S. 62-110.1(a) for construction of a 3-MW solar generating facility to be located at 4290 Red Cedar Road in Gibsonville, Guilford County, North Carolina. The Applicant plans to sell the electricity to Duke Energy Carolinas, LLC.

If no complaint is received within the time specified above and if the Commission does not order a hearing upon its own initiative, the Commission will enter an order awarding the certificate sought by the Applicant. Persons desiring to lodge complaints may file statements to that effect with the Commission.
