NOW COMES Duke Energy Carolinas, LLC (“DEC” or the “Company”) and respectfully moves the North Carolina Utilities Commission (the “Commission”) to withdraw certain exhibits filed on May 16, 2022 in this docket. In support of this Motion, the Company shows the following:

1. On March 1, 2022, the Company filed its Application for Approval of Demand-Side Management and Energy Efficiency Cost Recovery Rider (“Application”) in the above-referenced docket. The Application was supported by the Direct Testimony and Exhibits of Shannon R. Listebarger and the Direct Testimony and Exhibits of Robert P. Evans.


2. On May 16, 2022, DEC filed the Supplemental Testimony and Exhibits of witness Listebarger to present revised rates reflecting updates and corrections to the calculation of the interest or return due on over- or under-collections on Listebarger Exhibit No. 1, 2 and 3. The Supplemental Exhibits also included and renamed several exhibits that were not updated; i.e., Listebarger Supplemental Exhibit Nos. 4, 5 and 6 and Evans Supplemental Exhibit Nos. 1, 2, 3, 4, 7, 8 and 10. Because these exhibits were not

updated, the Companies filed them in error with the Supplemental filing, and they should not have been included.

3. To provide clarity about which exhibits were updated in the May 16, 2022 filing, the Company hereby respectfully requests leave to withdraw Listebarger Supplemental Exhibit Nos. 4, 5 and 6 and Evans Supplemental Exhibit Nos. 1, 2, 3, 4, 7, 8 and 10 from the May 16, 2022 filing.

WHEREFORE, the Company respectfully requests that the Commission grant the request to withdraw Listebarger Supplemental Exhibit Nos. 4, 5 and 6 and Evans Supplemental Exhibit Nos. 1, 2, 3, 4, 7, 8 and 10 from the May 16, 2022 filing and grant such other relief that the Commission deems just and proper.


