NOW COMES the Public Staff by and through its Executive Director, Christopher J. Ayers ("Public Staff"); Duke Energy Carolinas, LLC ("DE Carolinas"); and Duke Energy Progress, LLC ("DE Progress") (DE Carolinas and DE Progress, each a "Company" and collectively the "Companies") (Public Staff and the Companies, collectively, "Movants"), by and through their legal counsel and move:

- (i) That the remote, consolidated evidentiary hearing in the above-captioned dockets, currently scheduled to begin on July 28, 2020, be postponed until Monday, August 24, 2020;
- (ii) That the Commission accept Movants' filing of partial settlements in these dockets on or before August 3, 2020 as the Companies' response in satisfaction of the Commission's July 21, 2020 *Order on Duke Energy Carolinas, LLC's and Duke Energy Progress, LLC's Second Supplemental Testimony* ("July 21 Order on Second Supplemental Testimony"), and grant the Companies an extension of time to file such response from July 27, 2020, when such response is currently due, until the partial settlements are filed with the Commission; and
- (iii) That the Companies have eight additional days, or until August 5, 2020, to file the additional testimony and exhibits related to the Grid Improvement Plan requested by the Commission in its July 23, 2020 Order Requiring Duke Energy Carolinas, LLC, and Duke Energy Progress, LLC, to File Additional Testimony on Grid Improvement Plans and Coal Combustion Residual Costs ("July 23 Order Requiring Additional Testimony").

In support of this Joint Motion, Movants show as follows:

BACKGROUND

1. On September 30, 2019, DE Carolinas filed its rate case Application in Docket No. E-7, Sub 1214 (the "DE Carolinas Rate Case"). On October 29, 2019, the

Commission issued its *Order Establishing General Rate Case*, *Suspending Rates*, *Scheduling Hearings*, *and Requiring Public Notice*. Pursuant to that Order, *inter alia*, the Commission declared the DE Carolinas Rate Case to be a general rate case and scheduled an evidentiary expert witness hearing to begin on March 23, 2020. On March 16, 2020, in light of the novel Coronavirus ("COVID-19") pandemic, DE Carolinas filed a motion requesting that the Commission postpone the evidentiary hearing and suspend the procedural schedule. That same day, the Commission issued its Order Postponing Hearing and Addressing Procedural Matters postponing the evidentiary hearing until further order of the Commission.

- On October 30, 2019, DE Progress filed its rate case Application in Docket No. E-2, Sub 1219 (the "DE Progress Rate Case"). On November 14, 2019, the Commission issued its *Order Establishing General Rate Case and Suspending Rates* and on December 6, 2019, the Commission issued its *Order Scheduling Investigation and Hearings, Establishing Intervention and Testimony Due Dates and Discovery Guidelines, and Requiring Public Notice*. Pursuant to those Orders the Commission, *inter alia*, declared the DE Progress Rate Case to be a general rate case and scheduled an evidentiary expert witness hearing to begin on May 4, 2020. On March 24, 2020, as a result of the COVID-19 pandemic, the Commission issued its *Order Suspending Procedural Schedule and Continuing Hearing*, which continued the evidentiary hearing until further order of the Commission.
- 3. On May 6, 2020, the Movants filed a *Joint Motion to Consolidate Evidentiary Hearings* and on May 29, 2020, the Commission issued its *Order Proposing Procedures for Partially Consolidated Expert Witness Hearing*. Following a pre-hearing

conference held on June 6, 2020, the Commission issued its *Order Adopting Procedures* for Expert Witness Hearings on June 17, 2020, consolidating the Companies' rate cases for hearing to commence on July 27, 2020 to consider certain consolidated issues to be followed by hearings to consider DE Carolinas-specific issues and DE Progress-specific issues. On July 2, 2020, the Companies filed a list of proposed topics that the parties either support or do not oppose being considered during the consolidated phase of the hearing. On July 9, 2020, the Commission issued its *Order Accepting Recommended Consolidated Issues for Remote Expert Witness Hearing and Postponing Separate Issues Hearings* identifying the topics to be considered during the consolidated phase of the hearings to include: (1) financial issues including the rate of return on common equity, cost of debt, capital structure of the utilities to be used to determine the overall weighted cost of capital, and credit quality issues; (2) treatment of excess deferred income taxes; (3) the Grid Improvement Plan; and (4) affordability.

- 4. On July 21, 2020, the Commission issued its *Order on Duke Energy Carolinas, LLC's and Duke Energy Progress, LLC's Second Supplemental Testimony* requiring the Companies on or before July 27, 2020, to file a statement in their respective general rate case dockets electing one of the options set forth by the Commission in the Order concerning the Companies' May 2020 updates to certain pro forma adjustments.
- 5. On July 23, 2020, the Commission issued an *Order Requiring Duke Energy Carolinas*, *LLC*, and *Duke Energy Progress*, *LLC*, to File Additional Testimony on Grid Improvement Plans and Coal Combustion Residual Costs. This Order requires the Companies to file additional testimony and exhibits with information requested by the Commission concerning the Grid Improvement Plan on or before July 28, 2020.

6 On July 24, 2020, upon verbal motion of the Public Staff, the Commission issued an *Order Granting Continuance of Consolidated, Remote Hearing*, postponing the commencement of the consolidated hearing by one day to July 28, 2020, to allow additional time for continued settlement discussions between the Public Staff and the Companies.

STIPULATION WITH PUBLIC STAFF

- 7. On July 27, 2020, the Public Staff reached partial settlements in principle with each of the Companies regarding several remaining issues involved in DE Carolinas' and DE Progress' pending rate cases ("July 27 Settlements"), including issues that otherwise would have been litigated between the parties during the consolidated hearing. The Public Staff and the Companies will file the stipulations and agreements memorializing the July 27 Settlements on or before August 3, 2020. The Public Staff and the Companies anticipate that the July 27 Settlements will eliminate the need for a substantial amount of cross-examination of witnesses. Moreover, the Public Staff and the Companies believe that the delay in the hearing schedule will give all parties and the Commission an opportunity to review the July 27 Settlements prior to beginning the hearing, which potentially will lead to shorter and more efficient hearings. Therefore, the Public Staff and the Companies request that the remote, consolidated evidentiary hearing be delayed until Monday, August 24, 2020. The Commission already contemplates that the Company-specific evidentiary hearings will follow shortly thereafter, and the Movants at this time make no further request regarding those hearings.
- 8 Further, per the *July 21 Order on Second Supplemental Testimony*, the Companies are required to file a statement on or before July 27, 2020 electing whether to adopt or withdraw their Second Supplemental Testimony filed on July 2, 2020. The July

27 Settlements include an agreed timeline for the review and audit by the Public Staff of the Companies' Second Supplemental Testimony and the impact of the Companies' Second Supplemental Testimony on the partial settlements previously reached with the Public Staff. Accordingly, the Companies believe that the July 27 Settlements, once filed, will satisfy the Commission's directives to select an option, and therefore request that the July 27 Settlements serve as the response to the Commission's Order. To that end, Movants request that the Commission extend the time at which the Companies must respond to the *July 21 Order on Second Supplemental Testimony* through the date that Movants file the July 27 Settlements with the Commission.

9. Finally, the Companies request an additional eight (8) days, through August 5, 2020, to file the requested additional testimony and exhibits regarding the Grid Improvement Plan pursuant to the *July 23 Order Requiring Additional Testimony*. The Companies make this request to allow the Movants additional time to prepare and file the requested testimony to finalize the July 27 Settlements and related settlement testimony. With additional time to focus on the July 27 Settlements, the parties can improve the efficiency of the consolidated hearings by focusing the presentation of evidence and cross examination.

PUBLIC STAFF AND COMPANIES' REQUESTS

WHEREFORE, the Public Staff and the Companies respectfully request:

- 1. That the remote consolidated evidentiary hearing in the above-captioned dockets be postponed until Monday, August 24, 2020;
- 2. That the Commission accept the July 27 Settlements, when filed, as the Companies' response in satisfaction of the Commission's *July 21 Order on Second*

Supplemental Testimony, and that the Commission extend the Companies' deadlines to respond to the July 21 Order on Second Supplemental Testimony to the date the July 27 Settlements are filed;

- 3. That the Companies shall have until August 5, 2020, to file the additional testimony and exhibits the Commission ordered the Companies to file by July 28, 2020 pursuant to the Commission's *July 23 Order Requiring Additional Testimony*; and
- 4. For such other and further relief as the Commission may deem just and proper.

CONCLUSION

For the foregoing reasons, Movants respectfully request that the Commission issue an order granting the relief sought by this Joint Motion.
