NOW COME Duke Energy Carolinas, LLC ("DEC") and Duke Energy Progress, LLC ("DEP") (collectively the "Companies" or "Duke Energy") pursuant to Rule R1-7 of the Rules and Regulations of the North Carolina Utilities Commission ("Commission"), and move the Commission for a fifteen (15) day extension of time through and including March 30, 2023, for the Companies to file their Annual IEEE Standard 1547-2018 Implementation Status Report (the "IEEE 1547 Status Report") as required by the Commission's March 2, 2021 *Order Requiring Reports and Scheduling Presentation* ("IEEE 1547 Informational Order").

In support of this motion, the Companies show the Commission as follows:

1. On March 2, 2021, the Commission issued its IEEE 1547 Informational Order and directed the Companies to file on or before March 15, 2021 and annually thereafter: (1) the most recent version of IEEE Standard 1547; (2) the most recent version of the Companies' Implementation of IEEE Standard 1547-2018 Guidelines (the "Implementation Guidelines"); and (3) a narrative explanation of any stakeholder meetings that have occurred since its previous filing.

- 2. In compliance with the Commission's Order, the Companies' filed their first IEEE 1547 Status Report on March 15, 2021 and their second IEEE 1547 Status Report on March 15, 2022. The Commission took no additional action with respect to the Companies' reports filed in in 2021 and 2022.
- 3. The Companies have been working diligently to prepare their third annual IEEE 1547 Status Report for the 2022-2023 year. However, the Companies require additional time to prepare a thorough report and respectfully request that the Commission extend the response deadline fifteen (15) days to March 30, 2023.

WHEREFORE, Duke Energy Carolinas, LLC and Duke Energy Progress, LLC respectfully request that the Commission grant this Motion for a fifteen (15) day extension of time through and including March 30, 2023, for the Companies to file their annual IEEE 1547 Status Report and grant such other relief as the Commission deems just and proper.
