In ordering paragraph 4 of the Commission's November 18, 2021 Order Scheduling Hearing, Establishing Discovery Guidelines, and Requiring Customer Notice, Currituck Water and Sewer and Sandler Utilities are directed to file, separately, a verified report addressing all customer service and customer service quality complaints expressed during the public witness hearings held on February 2, 2022, within 15 days of the conclusion of that public witness hearing. Additionally, the Public Staff shall file a verified response to any comments on Currituck and Sanders' reports on or before February 24, 2022 as required by the scheduling order. By order dated February 8, 2022 the Commission has required additional information.

Transcripts of the February 2, 2022 hearing were filed with Commission on February 15, 2022.

In order appropriately to review the transcripts and comply with the requirements in the Commission's scheduling order, Currituck Water and Sewer respectfully requests an additional time of 15 days from the filing of the transcripts in order to comply with the Commission's November 18, 2021 and February 8, 2022 orders.

Currituck Water and Sewer is informed that Sandler Utilities concurs with and supports this request.
