5 Carolina Utilities Commission, and the Hearing
6 Examiner for this proceeding.

7 I now call for hearing Docket Number E-22,
8 Sub 674, which is the Virginia Electric and Power
9 Company, d/b/a Dominion Energy North Carolina's
10 Application for Approval of Renewable Energy and
11 Energy Efficiency Portfolio Standard Cost Recovery
12 Rider Pursuant to North Carolina General Statute
13 § 62-133.8 and Commission Rule R8-67.

14 On August 15th, 2023, Dominion filed its
15 Application to address approval of cost recovery for
16 compliance with the Renewable Energy and Energy
17 Efficiency Portfolio Standard.

19 witness testimony on this Application.

5 on behalf of the Using and Consuming Public.
