**PUBLIC NOTICE** 

NOTICE IS HEREBY GIVEN that the North Carolina Utilities Commission has scheduled a public hearing to be held on Wednesday, January 9, 2018, at 7:00 p.m. at the Edgecombe County Courthouse, 301 St. Andrew Street, Tarboro, North Carolina. The purpose of the hearing is to receive public witness testimony regarding the application of Edgecombe Solar LLC (Applicant), Public witness testimony will be received in accordance with Commission Rule

R1-21(g). On October 5, 2018, the Applicant filed an application pursuant to G.S. 62-110.1 and Commission Rule R8-63 for a certificate of public convenience and necessity (CPCN) to construct a 75-MWAC solar photovoltaic (PV) electric generating facility in Edgecombe County, North Carolina. The Applicant also filed for registration of the facility as a

new renewable energy facility. In support of the application for a CPCN, the Applicant filed the direct testimony of Ryan Van Portfliet and Meghan Schultz, as well as several exhibits. In summary, construction of the 75-MWAC solar PV facility is anticipated to begin in June 2019, with the expected commercial operation date being as early as January 1, 2020. The facility will include the solar arrays, inverters, a substation, and interconnection facilities. The location of the proposed facili-ty is approximately 600 acres of land on the north side of US Highway 64 Alternate West, east of the intersection with April Lane, and west of the intersection with Alston Lane, near Kingsboro, in Edgecombe County, North Carolina. The facility will interconnect with the electric transmission system owned by Virginia Electric and Power Company, d/b/a, Dominion North Carolina Power, The expected service life of the facility is 30 or more years.

Written statements are not evidence unless persons appear at a public hearing and testify concerning the information contained in their written statements.

Any person desiring to intervene in the proceeding as a formal party of record should file a petition under North Carolina Utilities Commission Rules R1-5 and R1-19 on or before Monday, December 31, 2018. Such petitions should be filed with the Chief Clerk of the North Carolina Utilities Commission, 4325 Mail Service Center, Raleigh, North Carolina 27699-4300. The direct testimony and exhibits of expert witnesses to be presented by intervenors should also be filed with the Commission on or before Monday, December 31, 2018.
