**MOTION FOR
EXTENSION
OF TIME**

NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission, by and through its Executive Director, Christopher J. Ayers, and respectfully requests that the Commission grant an extension of time for all interested parties to file comments pursuant to the Commission’s July 25, 2018, *Order Requesting Comments* in the above-captioned docket.

In support of this motion, the Public Staff shows the following:

1. On July 5, 2018, Duke Energy Carolinas, LLC (DEC), Northbrook Carolina Hydro II, LLC, and Northbrook Tuxedo, LLC (Northbrook, collectively the Applicants) filed a Joint Notice of Transfer, Request for Approval of Certificates of Public Convenience and Necessity, Request for Accounting Order and Request for Declaratory Ruling (Petition) in the above-captioned dockets.

2. On July 25, 2018, by its *Order Requesting Comments*, the Commission requested that the Public Staff and other intervenors file initial

comments on or before Monday, August 27, 2018, and that all parties file reply comments on or before Monday, September 10, 2018.

3. The Public Staff has been investigating this matter, but due to the press of business, it has not completed its investigation and comments. The Public Staff requests an extension to Tuesday, September 4, 2018, for all parties to file comments in this proceeding. In addition, the Public Staff requests a commensurate extension on the filing of reply comments by all parties from September 10, 2018 to Tuesday, September 18, 2018.

4. The Public Staff has contacted counsel DEC and Northbrook, and both parties indicated that they had no objections to the proposed extension.

WHEREFORE, the Public Staff respectfully requests that the Commission issue an order:

1. Extending the deadline for filing initial comments to Tuesday, September 4, 2018;
2. Extending the deadline for filing reply comments to Tuesday, September 18, 2018; and
3. For any further relief the Commission may deem just and proper.
