NOW COME Duke Energy Carolinas, LLC ("DEC") and Duke Energy Progress, Inc. ("DEP") (collectively "the Companies") pursuant to Commission Rule R1-7 and move the North Carolina Utilities Commission for a further extension of time through and including October 15, 2013 to file the Companies' 2013 Integrated Resource Plan Updates and REPS Compliance Plans. In support of this motion, DEC and DEP show the Commission as follows:

1. Pursuant to Commission Rules R8-60(h) and R8-67(b)(2), the Companies' 2013 IRP Updates and REPS Compliance Plans were originally due to be filed by September 3, 2013.

2. Pursuant to its August 28, 2013 *Order Granting Extension of Time*, the Commission granted DEC and DEP's August 22, 2013 joint motion for extension of time and extended the deadline for all electric public utilities to file their IRP Updates and REPS Compliance Plans until October 1, 2013.

3. As discussed in DEC and DEP's original motion, DEC and DEP are conducting additional modeling for their 2013 IRP Updates that should provide


useful information for the Commission and others who are interested in the Companies' resource planning. It is taking more time than anticipated to incorporate this work into the IRP Updates.

4. DEC and DEP contend that the benefits of the additional modeling should outweigh any potential harm caused by granting the Companies additional time to file their IRP Updates.

5. DEC and DEP submit that their requested further extension of time will not prejudice the Commission or any party's ability to investigate DEC or DEP's 2013 IRP Updates or REPS Compliance Plans and is necessary to enable DEC and DEP to provide complete and accurate 2013 IRP Updates.

WHEREFORE, Duke Energy Carolinas and Duke Energy Progress respectfully request that the Commission grant their joint motion for further extension of time through and including October 15, 2013, to file their 2013 IRP Updates and REPS Compliance Plans, and grant such further relief as the Commission deems just and proper.


