NOW COMES Complainant Pinnacle Bank, as successor by merger with BANK OF NORTH CAROLINA, ("Pinnacle"), by and through the undersigned counsel, and moves that the Commission grant it a second extension of time to reply to the Answer of Respondent as directed via Order Serving Corrected Answers and Responses entered June 18, 2019 for a period of twenty (20) days through and including August 20, 2019. In support of this Motion, Pinnacle states the following:

- 1. Complainant initially filed its Complaint on May 2, 2019.
- 2. Following receipt of Respondent's Answer, on June 27, 2019, Complainant filed its first motion for extension of time to reply to the Answer of Respondent, which was allowed by the Commission on July 1, 2019.
- 3. On July 31, 2019, Complainant filed its second first motion for extension of time to reply to the Answer of Respondent, which was allowed by the Commission on August 1, 2019.

- 4. On August 19, 2019, Complainant filed its third first motion for extension of time to reply to the Answer of Respondent, which was allowed by the Commission on August 22, 2019.
- 5. The present deadline before which Complainant is charged with responding to the Answer of Respondent is September 20, 2019.
- 6. In connection with the aforementioned motion, Counsel for Complainant and Counsel for Respondent indicated a need for additional time to exchange information relevant to the issues raised in the Complaint and to discuss options to resolve the dispute. Complainant and Respondent remain engaged in active discussions and requests additional time to respond to the Answer of Respondent to allow those discussions to continue in good faith.
- 7. Complainant does not yet know whether a hearing on the matters raised in the Complaint will be requested, but would like to provide the parties with a continued opportunity to exchange information and engage in further discussions before requesting such a hearing.
- 8. Complainant hereby submits to the Commission a request for a thirty (30) day extension of time to submit a reply to the Answer of Respondent up to and including October 21, 2019.
- 9. Counsel for Complainant has conferred with Counsel for Respondent, and Counsel for Respondent has consented to the request for an extension as outlined herein.
- 10. This Motion is timely filed on or before the Commission's prior Order seeking a response on or before September 20, 2019.

WHEREFORE, the undersigned counsel for Complainant Pinnacle respectfully requests that the Commission issue an Order Granting Extension of Time through and including October 21, 2019 to submit a response to the Answer of Respondent.
