BY THE CHAIR: As of the date of this Order, the public utilities listed on Appendix A attached hereto have failed to file the Public Utility Regulatory Fee Reports and/or pay the applicable fee(s) for some or all of the four quarters for the applicable fiscal year(s) as required by N.C. Gen. Stat. § 62-302.

N.C.G.S. § 62-36 provides, in pertinent part, as follows:

The Commission may require any public utility to file . . . special reports concerning any matter about which the Commission is authorized to inquire or to keep informed, or which it is required to enforce. . . . The Commission may issue an order, without notice or hearing, canceling or suspending any certificate of convenience and necessity or any certificate of authority 30 days after the date of service of the order for failing to file the required . . . report at the time it was due. In the event the report is filed during the 30-day period, the order of cancellation or suspension shall be null and void.

Since N.C.G.S. § 62-36 authorizes the Commission, without notice or hearing, to cancel a certificate for failure to file a required report, the Chairman concludes that this Order should be issued and that the certificate of public convenience and necessity held by each such public utility should be canceled pursuant to N.C.G.S. § 62-36 effective 30 days after the date of service of this Order, unless each such public utility files the required regulatory report(s) and/or fee(s) within said 30-day period. Inquiries regarding the status of such reports should be directed to the Fiscal Management Division of the North Carolina Utilities Commission at (919) 733-7680.

IT IS, THEREFORE, ORDERED as follows:

- 1. That the certificate of public convenience and necessity held by each public utility listed on Appendix A attached hereto shall be canceled effective 30 days after the date of service of this Order if said public utility fails to file the required regulatory report and/or fee;
- 2. That, if the required regulatory fee(s) and/or report(s) are filed by a public utility listed on Appendix A attached hereto before the expiration of 30 days after the date of service of the present Order, the cancelation provision of this Order shall be null and void as to that public utility; and
- 3. That the Chief Clerk shall serve a copy of this Order on each of the public utilities listed on Appendix A attached hereto by means of United States certified mail, return receipt required.
