NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission (Public Staff), by and through its Executive Director, Christopher J. Ayers, and respectfully moves the Commission for a one-day continuance of the evidentiary hearing scheduled to commence on June 8, 2022 to and until 10:00 a.m. Thursday, June 9, 2022, to allow the Public Staff , Currituck Water and Sewer, LLC (Currituck), and Sandler Utilities at Mill Run, LLC (Sandler) (Currituck and Sandler are collectively referred to as the “Companies”) to complete settlement negotiations in this proceeding. In support of this motion, the Public Staff respectfully shows the Commission the following:

1. On May 5, 2022, Currituck filed with the Commission a motion for three-week continuance of the evidentiary hearing previously scheduled by the Commission for May 9, 2022. The subject motion informed the Commission that

the parties to the dockets were engaged in discussions in an effort to resolve some or all of the contested outstanding issues and, if after three weeks, the parties were unable to reach agreement, any party could file a motion with the Commission to reschedule the hearing.

2. On May 6, 2022, the Commission issued an order continuing the expert witness hearing to 10 a.m. on Wednesday June 8, 2022, and continuing as necessary until its conclusion.

3. The parties to this proceeding are making significant progress toward reaching agreement on all issues in this proceeding and intend to file a Stipulation and Settlement Agreement by Monday, June 6, 2022.

4. In order to provide the Commission with adequate time to review and evaluate the proposed Stipulation, the Public Staff, therefore, respectfully requests that the Commission grant the parties a one-day continuance of the expert witness hearing to Thursday, June 9, 2022, at 10:00 a.m.

5. The Public Staff has consulted with counsel for Currituck and Sandler, and they do not object to this motion.

6. WHEREFORE, for the reasons set forth above, the Public Staff respectfully requests a one-day continuance of the evidentiary hearing presently scheduled to commence June 8, 2022, in this proceeding and grant any further relief as the Commission deems just and necessary.
