NOW COMES AQUA NORTH CAROLINA, INC. ("Aqua" or "Company"), by and through the undersigned counsel, to respond to the "Response of the Public Staff to Aqua Notice That No Refunds of Commission-Authorized Temporary, Interim Rates Collected Under Bond Are Required Pursuant to N.C.G.S. § 62-135", filed on September 28, 2023.

On July 28, 2023, Aqua filed a notice that no refunds were due related to the interim rates that were authorized by the Commission effective February 19, 2023. In this filing, the Company compared the annual revenue requirements - by rate entity – from the interim rates effective February 19, 2023, to the annual revenue requirements from the final order. That analysis showed that, for each rate division, the revenue requirement used for developing the rates under bond was less than the amounts in the final rate order and thus no refunds were

warranted. This was consistent with the Company's no refund filing from Docket No. W-218, Sub 526.

Based on the NC Public Staff filing of September 28, 2023, the Company agrees to (1) issue refunds to Aqua Uniform Sewer customers charged under the Hawthorne at the Greene Apartments, Woodland Farm (Rocky Ridge), and Beaver Farms Subdivision – Mecklenburg County rate classification of \$1.07 per 1,000 gallons plus interest at a rate of 10% per annum, for usage during the effective period of temporary rates from February 19, 2023, through June 4, 2023; (2) that, prior to issuing refunds, Aqua consult with the Public Staff when determining whether refunds are necessary and, if so, the appropriate amount of refunds; and (3) that Aqua file notice in the subject docket within 14 days of issuing the required refunds.
