BY THE CHAIRMAN: On June 15, 2017, Fresh Air II, LLC, filed a verified Complaint regarding two interconnection requests described as Complainant Younts PV1 and Complainant Round Hill PV1 (collectively the Complainants) in the above-captioned docket against Duke Energy Carolinas, LLC (DEC).

On August 23, 2017, the Commission issued an Order Scheduling Hearing.

On September 12, 2017, Complainants filed a Motion for Continuance of Hearing indicating that the parties are attempting to resolve the dispute and requesting that the hearing be continued to Monday, December 11, 2017, and that new deadlines for pre-filed testimony be set. On September 14, 2017, the Commission issued an Order Rescheduling Hearing.

On October 30, 2017, the Commission issued an Order Rescheduling Hearing due to unforeseen circumstances continuing the hearing to Monday, January 10, 2018, and new deadlines for pre-filed testimony were set.

On December 28, 2017, Complainants filed a Motion for Continuance of Hearing indicating that the parties were still in negotiations to attempt to resolve the dispute. On January 3, 2018 the Commission issued an Order Continuing Hearing but the Order did not reschedule the hearing and pre-filed testimony dates.

After consultation with the parties, the Chairman finds good cause to set the hearing to begin on March 12, 2018, at 1:00 p.m. and set new dates for pre-filed testimony.

IT IS, THEREFORE, ORDERED as follows:

1. That this docket is scheduled for hearing on Monday, March 12, 2018, beginning at 1:00 p.m., in Commission Hearing Room 2115, Dobbs Building, 430 North Salisbury Street, Raleigh, North Carolina;

2. That Complainants shall file direct testimony in support of the Complaint with the Commission on or before Wednesday, February 7, 2018, and shall serve Respondent;

3. That Respondent shall file direct testimony with the Commission on or before Tuesday, February 27, 2018, and shall serve Complainants; and

4. That Complainants may file rebuttal testimony, if any, with the Commission on or before Tuesday, March 6, 2018, and shall serve Respondent.
