Duke Energy Progress, LLC ("DEP") and Duke Energy Carolinas, LLC ("DEC") (collectively, the "Companies") have maintained a tariff known as the Renewable Advantage Program since October 15, 2019, when the Commission issued its Order Approving Renewable Advantage Rider and NC GreenPower Program Changes in the above-referenced dockets.

Earlier this year, the Companies received a cease-and-desist letter that demanded the Companies stop using the name "Renewable Advantage." Rather than resisting the request, the Companies decided that the best and simplest resolution is to adopt a name change. Accordingly, the Companies are notifying to the Commission that the name of the program is being changed to "Go Renewable." The name change will be implemented on customers' bills and the Companies' websites by January 31, 2024.

In order to transition to the new name and avoid confusion, the Companies will pause marketing for the program on December 15, 2023, until marketing materials are updated, and the name change is finalized. Also, the Companies will notify all current program participants of the name change by email prior to implementing the new name.

Notably, all other aspects of the tariff will remain the same, as approved by the Commission. As such, Commission action is not required to approve the program's change in name.
