Dear Ms. Dunston:
Virginia Electric and Power Company, d/b/a Dominion Energy North Carolina ("DENC" or the "Company") filed its 2023 Integrated Resource Plan ("2023 Plan") with the North Carolina Utilities Commission ("Commission") in this docket on May 1, 2023, and subsequently corrected the 2023 Plan most recently on September 15, 2023. Also on May 1, 2023, DENC filed its 2023 REPS Compliance Plan.

On February 6, 2024, the Commission issued an Order Scheduling Public Hearing on 2023 Biennial Integrated Resource Plan and REPS Compliance Plan ("Scheduling Order"), scheduling a virtual public hearing for the purpose of receiving public witness testimony on the 2023 IRP and 2023 REPS Compliance Plan for May 6, 2024, at 7:00 pm. The Commission directed the Company to publish the Notice of Hearings attached as Appendix A to the Scheduling Order once a week for two consecutive weeks at least 30 days in advance of the public witness hearing, and file an affidavit of publication of the notice in this docket.

On May 1, 2024, the Commission issued an Order Cancelling Public Hearing on 2023 Biennial Integrated Resource Plan and REPS Compliance Plan as no public witnesses registered to testify at the remote public witness hearing pursuant to the Scheduling Order.

It has come to the Company's attention that due to administrative oversight associated with a change in personnel, the publication of notice directed by the Scheduling Order did not occur. The Company apologizes for the oversight and respectfully requests that the Commission issue an amended scheduling order setting a new public witness hearing date and appending an updated Notice of Public Hearing for publication.
