Dear Ms. Jarvis:

I am writing to correct an error in the Public Staff's Proposed Recommended Order Granting Partial Rate Increase and Requiring Customer Notice, filed on October 3, 2017, in the above-referenced docket. The Proposed Recommended Order was filed as an exhibit to the Public Staff's Motion for Order Granting Partial Rate Increase and Requiring Customer Notice.

In both Appendix A to the Proposed Recommended Order (the Schedule of Rates) and Appendix B (the Notice to Customers of New Rates), there was a line that read as follows: "Billing Frequency: Shall be monthly for service in arrears." This line was incorrect; it should have read: "Billing Frequency: Shall be monthly for service in advance." Enclosed with this letter are corrected versions of the two appendices; we request that they be substituted for the original appendices.

NOTICE TO CUSTOMERS OF NEW RATES

BY THE COMMISSION: Notice is given that the North Carolina Utilities Commission has granted a rate increase to John W. Gensinger d/b/a Pineview Water System (Applicant) for water utility service provided in Pineview Estates Subdivision in Wake County, North Carolina.

The Commission's decision followed customer notice and investigation by the Public Staff. The Commission issued an order on June 6, 2017, requiring the Applicant to provide customer notice stating that the matter may be determined without public hearing if no significant protests were received subsequent to customer notice. No customer protests were received. On September 22, 2017, the Commission ordered that the hearing be canceled due to the lack of protests received and the fact that the Public Staff had reached agreement with the Applicant as to the appropriate rates to be charged.
