BY THE PRESIDING COMMISSIONER: On December 6, 2021, Public Service Company of North Carolina, Inc. d/b/a Dominion Energy North Carolina (PSNC), and the Public Staff filed their proposed Energy Efficiency Tracker – Rider F and Cost Recovery Mechanism for Energy Efficiency Programs Pilot (EE Mechanism). The EE Mechanism provides, among other things, for an annual EE rate rider calculated to allow PSNC to recover its costs of operating EE programs. Further, the EE Mechanism provides that the initial rider would be effective on November 1, 2021, in the amount of \$0 per therm, that PSNC and the Public Staff would work together to determine the second set of EE rider rates consistent with the Mechanism, and would file the proposed second set of rates no later than 45 days after the Commission's order approving base rates in Docket No. G-5, Sub 632. In addition, the EE Mechanism states that the second set of rates, if approved by the Commission, would be effective no later than June 1, 2022.

On January 21, 2022, the Commission issued an Order Approving Stipulation, Granting Rate Increase, and Requiring Customer Notice. In its Order, the Commission found that it was reasonable and appropriate to commence the three-year EE pilot program as of November 1, 2021, as set forth in the EE Mechanism. As a result, PSNC is required to file the second set of EE rates by March 7, 2022.

On March 2, 2022, PSNC filed a letter requesting that the time for it to file the second set of rates be extended to April 15, 2022. In support of its motion, PSNC stated that PSNC and the Public Staff have been working together on the second set of rates but need

additional time to finalize them. PSNC further stated that the Public Staff had reviewed the motion and supports the requested extension of time.

Based on the motion and the record, the Presiding Commissioner finds good cause to grant the motion to extend the date for PSNC to file the second set of rates to April 15, 2022.

IT IS, THEREFORE, SO ORDERED.
