Pursuant to Ordering Paragraph 7 at page 6 of the *Order Scheduling Hearing, Establishing Intervention and Testimony Due Dates and Discovery Guidelines, and Requiring Notice*, entered by the North Carolina Utilities Commission ("Commission") in Docket No. W-218, Sub 573 on September 8, 2022, Aqua North Carolina, Inc. ("Aqua" or "Company") hereby provides to the Public Staff and files with the Commission updated information with supporting data, along with updated schedules, through July 31, 2022, which the Company proposes to use to supplement its rate case application and request for rate relief in this docket.
