NOTICE IS HEREBY GIVEN that on September 23, 2016, Pecan Solar, LLC (Applicant), filed an amended application seeking a certificate of public convenience and necessity (CPCN) pursuant to G.S. 62-110.1 (a) for construction of a 74.9-MW AC solar generating facility to be located east and west of Bethel Church Road, approximately 0.6 to 2 miles north of the intersection of Bethel Church Road and Highway 158, in an unincorporated area approximately 2 miles east of Seaboard, Northampton County, North Carolina.

On August 25, 2016, a complaint was filed with the Commission in this docket. Based upon the complaint and the record herein, the Commission has scheduled a public hearing to receive evidence as to whether a CPCN should be awarded to the Applicant. The public hearing will be held on Wednesday, December 7, 2016 at 6:00 p.m. at the Northampton County Courthouse, 102 West Jefferson Street, Jackson, North Carolina.


