BY THE CHAIRMAN: On February 25, 2015, in Docket No. SP-751, Sub 19, the Commission issued a certificate of public convenience and necessity (CPCN) to SunEnergy1, LLC (SunEnergy1) for construction of a 12-MW solar photovoltaic electric generating facility to be located on the north side of Watson Seed Farm Road at the intersection with Bellamy Mill Road in Whitakers, Nash County, North Carolina.

On March 12, 2015, SunEnergy1 and Colonial Eagle Solar, LLC (Colonial Eagle) filed a statement with the Commission in Docket Nos. SP- 751, Sub 19 and SP-4305, Sub 4 requesting that the Commission transfer the CPCN for the facility from SunEnergy1 to Colonial Eagle.

Based on the foregoing and the record in these dockets, the Chairman finds good cause to transfer the CPCN for the facility from SunEnergy1 to Colonial Eagle, cancel the CPCN issued to SunEnergy1, issue a new CPCN to Colonial Eagle, and close Docket No. SP-751, Sub 19.

IT IS, THEREFORE, ORDERED as follows:

1. That the application filed by SunEnergy1, LLC, and Colonial Eagle Solar, LLC, to transfer the certificate of public convenience and necessity for construction of a 12-MW photovoltaic electric generating facility to be located on the north side of Watson Seed Farm Road at the intersection with Bellamy Mill Road in Whitakers, Nash County, North Carolina, to Colonial Eagle Solar, LLC, shall be, and is hereby, approved.

2. That Appendix A shall constitute the amended certificate of public convenience and necessity reflecting the transfer of the certificate to Colonial Eagle Solar, LLC.


3. That the certificate of public convenience and necessity issued to SunEnergy1, LLC, in Docket No. SP-751, Sub 19 for this solar photovoltaic facility shall be, and is hereby, cancelled.

4. That the Chief Clerk shall close Docket No. SP-751, Sub 19.


