Attached for filing please find the Proposed Order, submitted by Carolina Water Service, Inc. of North Carolina ("CWSNC" or "Company") in compliance with the Commission's Scheduling Order of September 2, 2022 and its two orders extending the time for filing (January 11th and 31st, 2023). Also included herein are Appendices A – G and the Schellinger Affidavit of Rate Case Expenses. The Public Staff is filing Updated Public Staff Settlement Exhibit 1; CWSNC and the Public Staff request that it be entered into evidence. Additionally, CWSNC requests that the Schellinger Affidavit of Rate Case Expenses be entered into evidence in the docket.

On November 22, 2022, CWSNC and the Public Staff (Parties) reached a settlement in this case of all issues except two: Return on Equity (ROE) and the application of the statutory WSIP 5% rate cap. Particularly because of the impact of ROE on proposed rates, it is necessary for the Parties to file separate Proposed Orders. However, the Parties worked together to synchronize their proposed orders as much as possible. Accordingly, the Parties' respective proposed orders

largely track each other except for the findings, discussions, and conclusions concerning the two disputed issues and the resulting revenues, revenue requirements, and rates. Finally, as the Parties have better understood the Commission's expectations regarding penalties and incentives, they have committed to the Commission to file a Supplemental Proposed Order (or Orders), by March 17, 2023, to address those topics sooner than had been agreed upon by the Parties in the Settlement Agreement.
