Dear Ms. Campbell:

On May 4, 2021, Duke Energy Carolinas, LLC ("DEC" or the "Company") advised the Commission of an error in the amount of Renewable Energy Certificates ("RECs") from net metering facilities that had been reported to the North Carolina Renewable Energy Tracking System ("NC-RETS") and requested a waiver of Section 5.4 of the NC-RETS Operating Procedures, which allows an account holder to apply for a prior period adjustment to adjust the meter data submitted to create RECs within a year of the generation of the energy that is associated with the REC. On May 5, 2021, DEC filed supplemental testimony and revised exhibits showing the associated corrections. On May 11, 2021, the Commission issued an order granting waiver of the NC-RETS Operating Procedures Section 5.4 and approving the prior period adjustment requested.


After the REC retirements were officially recorded, the Company identified additional changes needed to correct Table 1 of the 2020 REPS Compliance Report (Jennings Exhibit No. 1, page 4). These changes do not affect DEC's proposed rider calculations in any way. Certain information contained in Jennings Exhibit No. 1 is a trade secret, and confidential, proprietary, and commercially sensitive information. For that reason, DEC's June 24, 2021 revision to Table 1 on page 4 of DEC's Compliance Report is being filed under seal pursuant to N.C. Gen. Stat. §132-1.2. Parties to the docket may contact the Company regarding obtaining copies pursuant to an appropriate confidentiality agreement.

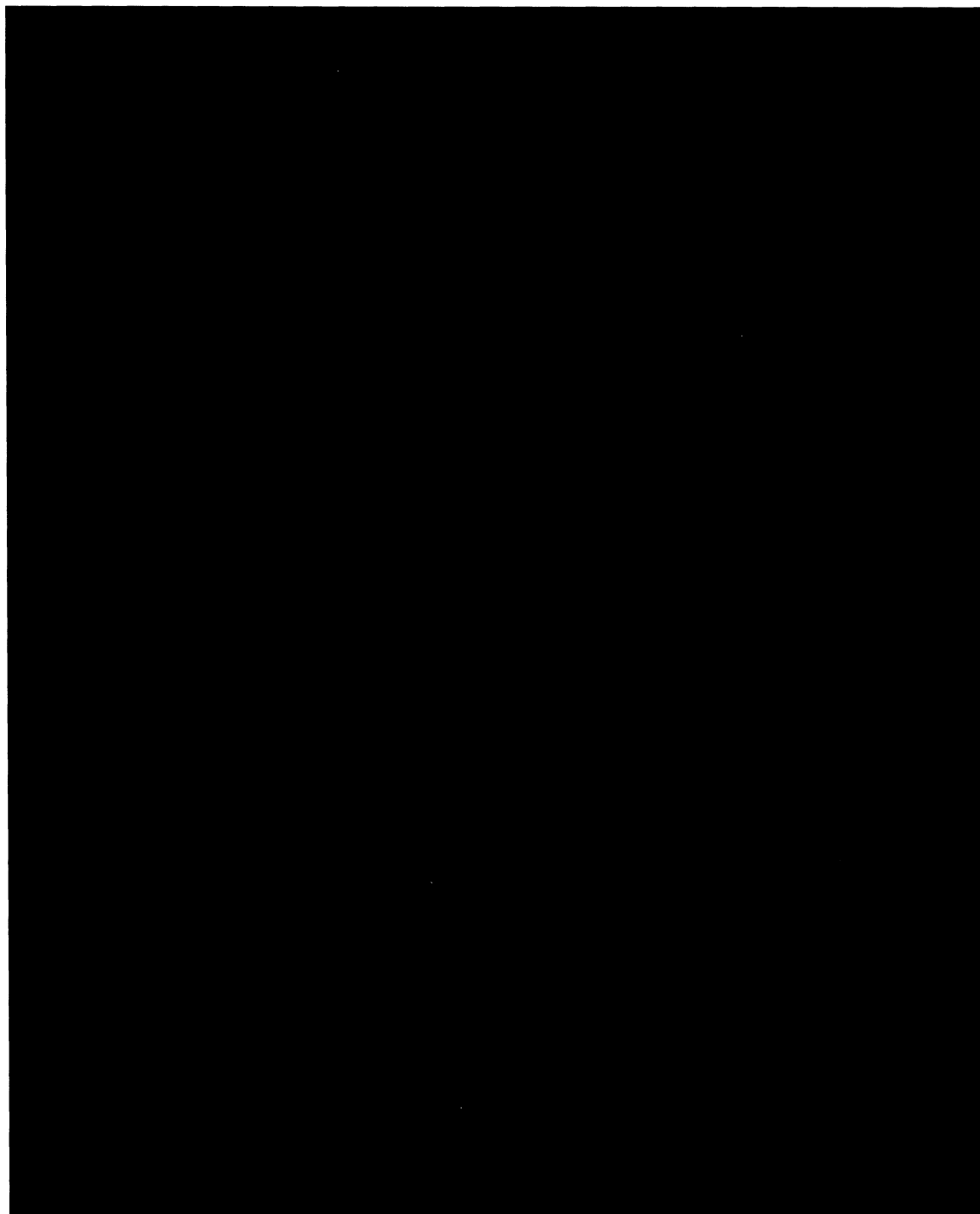


