ATTORNEY GENERAL'S
OFFICE'S MOTION FOR
EXTENSION OF TIME

NOW COMES the North Carolina Attorney General's Office (AGO) and respectfully requests a second thirty-day extension of the deadlines for all parties to file supplemental comments in the above-captioned docket. In support of this motion, the AGO shows the following:

1. On April 22, 2022, the Commission issued an order directing Duke Energy Progress, LLC (DEP), Duke Energy Carolinas, LLC (DEC) (and collectively with DEC, Duke), Virginia Electric and Power Company, Inc., d/b/a Dominion Energy North Carolina, and the Public Staff - North Carolina Utilities Commission to file comments on the implementation of, and any updates to, the utilities' respective customer billing and data management systems, and the utilities advanced metering infrastructure, explaining how these developments inform or affect previously filed comments in this proceeding.

2. The Order also encouraged, without requiring, other intervenors to file supplemental comments on these and other relevant developments since the filing of past comments.

3. On May 18, 2022, the Commission allowed a motion from Duke for a thirty-day extension of the deadlines for all parties to file supplemental comments, moving the deadline for initial supplemental comments to June 22, 2022 and the deadline for supplemental reply comments to July 7, 2022.

4. The AGO has been working diligently on supplemental comments but needs more time to review discovery and confer with other parties about developments. The undersigned came down with Covid symptoms at the time when discovery responses became available, resulting in delay, and is also involved in other matters at the Commission and in the Court of Appeals.

5. The undersigned has communicated with counsel for parties to this docket about this request, and Duke, Dominion, Public Staff, NC Warn, CIGFUR, the North Carolina Sustainable Energy Association, Southern Alliance for Clean Energy, Sierra Club, NRDC, and Mission:data responded that they do not object to the requested extensions. Further, no other parties have responded with any objections to the request.

Wherefore, the Attorney General's Office respectfully requests an extension of thirty (30) days, up to and including July 22, 2022, for all parties to file supplemental comments in this matter, and a like extension of the deadline for all parties to file supplemental reply comments to August 8, 2022.
