Pursuant to Commission Rules R1-17 and R1-28, Pluris Webb Creek, LLC ("Pluris") files the enclosed Application for Rate Increase in the above-referenced docket. Attached to the Application are schedules providing the information required by NCUC Form W-1. Pluris also files herewith the Direct Non-Confidential Testimony of Maurice Gallarda and the Direct Testimony of Daniel Winters. In connection with this filing we have made payment of the \$250 filing fee required for a Class B sewer company.

As provided for in the *Order Appointing Emergency Operator, Approving Increased Rates, And Requiring Customer Notice* issued August 8, 2016, in Docket W-864, Sub 11, and the *Order Revoking Webb Creek Water And Sewage, Inc.'s Franchise, Granting Certificate Of Public Convenience And Necessity To Pluris Webb Creek, LLC, Continuing Interim Rates, Discharging Emergency Operator, And Requiring Customer Notice*, issued March 26, 2019, in Dockets W-864, Sub 14 and W-1314, Pluris also files a Final Accounting relating to the provisional rates established when it was appointed as Emergency Operator of the Webb Creek system.

Pluris reserves the right to further update its cost of service and investment, as allowed by Chapter 62, up until the close of the evidentiary hearing in this matter.

As required by Rule R1-28(b)(1), Pluris will file 15 paper copies of these materials with the Commission at a future time, in accordance with the Commission's Order regarding the resumption of the filing of paper copies.
