



NOTICE IS HEREBY GIVEN that on February 23, 2015, Shine Solar I, LLC (Applicant), filed an application seeking a certificate of public convenience and necessity pursuant to G.S. 62-110.1(a) for construction of a 4.999-MW solar generating facility to be located at 1479-A Oak Grove Church Road in Ellenboro, Rutherford County, North Carolina. The Applicant plans to sell the electricity to Duke Energy Carolinas, LLC.

If no complaint is received within the time specified above and if the Commission does not order a hearing upon its own initiative, the Commission will enter an order awarding the certificate sought by the Applicant.
