On April 4, 2018, New River Light and Power Company ("NRLP") filed, pursuant to ordering paragraphs 3 and 4 of the Order Accepting Stipulation and Granting Increase in Rates, issued by the North Carolina Utilities Commission (the "Commission") on March 29, 2018 in the captioned Docket (the "Order"), the following for review and approval by the Commission:

1. Revised Rates Schedules:
2. NRLP's 2017 Service Regulations; and
3. Proposed Notice to Customers of Change in Rates.
