On February 15, 2021, GESS RNG Biogas USA, LLC ("GESS RNG") filed its Motion to Amend Order Approving Participation in Pilot Program with Conditions and its Second Supplemental and Amended Requests for Declaratory Rulings ("Filings") in this docket. In the Filings, GESS RNG stated that it is successor in interest to GESS International North Carolina, Inc. ("GESS International") and that GESS International has assigned and transferred all of its rights and interests in this matter to GESS RNG.

On February 17, 2021, Duke Energy Carolinas, LLC ("DEC") and Duke Energy Progress, LLC ("DEP") jointly filed a letter in response to GESS RNG's Filing in this docket ("DEC/DEP Letter"). In the DEC/DEP letter, the electric companies state that DEC and DEP are not likely to use Alternative Gas from GESS RNG due to prior contracts with GESS International having been terminated due to failure to perform.

In light of the foregoing, Piedmont Natural Gas Company, Inc. ("Piedmont") takes no position on the underlying merits of GESS RNG's filings but would remind the Commission that Appendix F of Piedmont's North Carolina Service Regulations requires that all Alternative Gas delivered to Piedmont must be nominated for use by and allocated to a Piedmont Customer. If DEC and DEP are not GESS RNG's customers, which appears to be the case, then the current record may not be sufficient to support Piedmont's receipt of Alternative Gas from GESS RNG facilities.
