NOW COMES Duke Energy Progress, LLC (“DEP” or the “Company”), by and through counsel and pursuant to Rule R1-7 of the Rules and Regulations of the North Carolina Utilities Commission (“Commission”), and respectfully requests that the Commission enter an order granting a one-week extension of time until November 6, 2020 for DEP to file rebuttal testimony.

DEP shows the Commission the following:


1. That based on the Public Staff’s testimony of Jeff Thomas filed on October 20, 2020, the Company needs additional time to review, evaluate and comment on the proposals listed by Mr. Thomas to reduce the cost of the facility. Without agreeing that the proposals listed by Mr. Thomas are necessary, Company review and evaluation includes meetings with Buncombe County officials to determine if any of the proposals set forth by Mr. Thomas can be acceptable to Buncombe County and to the Company. In addition, consideration of the proposals requires meetings with Company personnel to

help the project team responsible for this filing to evaluate whether any of the proposals are acceptable.

2. The Company has consulted with counsel for the Public Staff, and the Public Staff has no objection to a one-week time extension for the Company to file rebuttal testimony.

WHEREFORE, the Company respectfully requests that the Commission grant an extension of time until November 6, 2020 to file rebuttal testimony.


