NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission, by and through its Executive Director, Christopher J. Ayers, and moves that the public and evidentiary hearings previously scheduled on this matter be canceled and that the Public Staff's testimony, affidavits, and exhibits be entered into evidence. In support of this motion the Public Staff respectfully shows unto the Commission:

- 1. This proceeding began with the filing of an Application for Rate Increase by JAARS, Inc. (JAARS or the Company) on June 23, 2020.
- 2. In an order issued July 20, 2020, the Commission declared the proceeding to be a general rate case and suspended rates for up to 270 days.
- 3. By order dated September 4, 2020, the Commission scheduled a remote customer hearing at 6:30 p.m., on Wednesday, October 28, 2020. The hearing was scheduled subject to cancellation if no significant protests were received by October 9, 2020.

- 4. By order dated September 4, 2020, the Commission scheduled an evidentiary hearing to begin at 10:00 a.m., on Tuesday, November 10, 2020.
- 5. In a certificate of service filed on September 15, 2020, the Company indicated that all affected customers had been served with notice of the proposed rate increase and hearing.
- 6. The Public Staff did not receive any protests and no one registered to provide testimony at the public hearing by the deadline established in the customer notice.
- 7. The Company filed a Letter of Concurrence agreeing with the rates recommended by the Public Staff on October 13, 2020.
- 8. The Public Staff requests that the public and evidentiary hearings, scheduled for Wednesday, October 28, 2020, and Tuesday, November 10, 2020, respectively, be cancelled, and that the testimony and exhibits of Public Staff witnesses Gina Y. Casselberry and June Chiu, and the affidavit of Public Staff witness Calvin C. Craig, III, be entered into evidence. The Public Staff has contacted the Company, and it has no objection to cancelling the public and evidentiary hearings.
 - 9. A proposed order is being filed with this motion.

WHEREFORE, the Public Staff prays:

- 1. That the Commission grant the Public Staff's request to cancel the public hearing scheduled for Wednesday, October 28, 2020 at 6:30 p.m. and the evidentiary hearing scheduled for Tuesday, November 10, 2020 at 10:00 a.m.
 - 2. That the testimony and exhibits of Public Staff witnesses Gina Y.

Casselberry and June Chiu and the affidavit of Public Staff witness Calvin C. Craig, III, be entered into the record.

- 3. That JAARS be ordered to notify its customers of the cancellation of the hearings; and
- 4. For such other and further relief as the Commission may deem just and proper.

BY THE COMMISSION: This proceeding began with the filing of an application for rate increase by JAARS, Inc. (JAARS or the Company) on June 23, 2020. In an order issued on July 20, 2020, the Commission declared the proceeding to be a general rate case and suspended the proposed new rates for up to 270 days. By order dated September 4, 2020, the Commission scheduled a remote customer hearing, at 6:30 p.m., on Wednesday, October 28, 2020, and an evidentiary hearing beginning at 10:00 a.m., on Tuesday, November 10, 2020. The customer hearing was scheduled subject to cancelation if no significant protests were received by October 9, 2020. The Public Staff did not receive any protests and no one registered to provide testimony at the public deadline. On October 13, 2020, the Company filed a Letter of Concurrence in which it consented to the rates recommended by the Public Staff

On October **, 2020, the Public Staff filed a Motion to Cancel Hearing. In its motion the Public Staff stated that the Company had filed the requisite Certificate of Service, which attested that all affected customers received notice of the rate increase and the hearing; it did not receive any protests; no one registered to provide

testimony at the public hearing by the deadline established in the customer notice; and the Company submitted a Letter of Concurrence in which it consented to the rates recommended by the Public Staff. The motion also states that the Public Staff contacted the Company and it has no objection to cancelling either hearing. The motion requested cancellation of both hearings as well as admission of prefiled testimony, exhibits, and affidavits of Public Staff witnesses Calvin C. Craig, III; Gina Y. Casselberry, and June Chiu.

Based upon the foregoing, the Commission is of the opinion that the hearings scheduled for October 28, 2020, and November 10, 2020, should be canceled; customer notice of said cancelations should be required; the testimony, exhibits, and affidavits of Public Staff witnesses listed above should be admitted into evidence in this proceeding.

IT IS, THEREFORE, ORDERED as follows:

- That the remote public hearing previously scheduled for Wednesday, October 15, 2020, is canceled.
- That the evidentiary hearing previously scheduled for Tuesday, November
 10, 2020, is cancelled;
- That the testimony, exhibits, and affidavits of Public Staff witnesses Calvin
 Craig, III; Gina Y. Casselberry; and June Chiu be entered into the record; and
