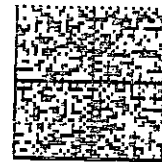
The Chairman is of the opinion that good cause exists to allow the requested intervention by CUCA.

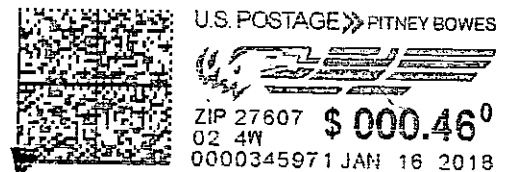
