6. A description of the buildings, structures and equipment comprising the generating facility and the manner of their operation

The PV system will be utility interactive ("grid-tied"), and does not have battery backup. It will consist of thirty-six (36) 245W photovoltaic modules, which will be mounted to a free-standing, fixed tilt, steel structure adjacent to the guest cabin. The PV inverter, disconnects, and other pertinent equipment will be mounted on the guest cabin in a manner that complies with NEC 2014, and all equipment will be near the existing electrical service. It will connect to that electrical service provided by Pee Dee Electric Membership Corporation ("PDEMC").

- 7. The projected maximum dependable capacity of facility in megawatts. Nameplate capacity is 0.0077MW AC. Since solar photovoltaics is an intermittent energy source, maximum dependable capacity is 0MW AC.
- 8. The projected cost of the facility is \$47,480.00.
- 9. The projected date on which the facility will come on line is May 2015.
- 10. The applicant's general plan for sale of the electricity to be generated, including the utility to which the applicant plans to sell the electricity, any provisions for wheeling of the electricity, arrangements for firm, non-firm or emergency generation, the service life of the project, the projected annual sales in kilowatt hours, and whether the applicant intends to produce renewable energy certificates that are eligible for compliance with the State's renewable energy and energy efficiency portfolio standard.

The plan is to use generated energy on site and net-meter excess energy to the serving utility, PDEMC. The expected service life of the project is twenty (20) years, with the opportunity to upgrade and modify the system to further system life beyond that point. The system is expected to generate approximately 12,300 kWh (AC) each year, while projected annual sales to PDEMC total approximately 4,300 kWh (AC).

There are no provisions for wheeling of the electricity, and no arrangements for firm, non-firm or emergency generation. Lastly, the Applicant does intend to produce renewable energy certificates that are eligible for compliance with the State's renewable energy and energy efficiency portfolio standard.






Map of:
