This is why we have chosen to purchase a hybrid Toyota Prius (our 2<sup>nd</sup> hybrid car), make our home more energy efficient, live in a passive solar home for about 37 years, purchased 16 photovoltaic panels for our roof to generate a small portion of our electrical needs, garden organically and rebuild our soil by adding organics each year. We want to be part of the Solution. We choose to work toward the Solution.

Now we just need the Utility Companies to think about more than profits and providing a bigger dividend to their stockholders and salaries to their officers.

We request to be treated like PARTNERS in electricity generation; making electricity for ourselves and to sell our excess during the sunniest conditions back to the Utility Company for them to use in the electrical grid as others most need it. We are members of a Rural Energy Co-Op (once called Davidson Electric and now call Energy United) who charge us each month for the use of their net meter and a Standby Fee because they must be ready to provide us electricity when it is cloudy/at night when we need to purchase electricity from them. We do receive a small credit each month for the electricity we have in excess that they sell to another in our grid. However the credit does not exceed the meter/standby fees. If we were allowed to purchase the meter (like we all now purchase landline phones rather than monthly rent the phones), then this might be a fairer arrangement. If there was no Standby Fee, it would be fairer.

By the way, we sold all of our DUKE POWER stock because we did not want to financially profit from quarterly dividends at the expense of our natural resources and the quality of life of future generations.

Please do all you can to save and reform Net Metering to reflect the partnership we have made available to the Utility Companies by generating solar electricity. **Note: Docket E-100, Sub 180CS in the subject line for more details.**
