Dear Ms. Dunston:

On July 25, 2022, at the North Carolina Utilities Commission (“Commission”) Staff Conference, the Commission considered a recommendation by the Public Staff – North Carolina Utilities Commission to approve the request by Public Service Company of North Carolina, Inc. d/b/a Dominion Energy North Carolina (the “Company”) for final approval of the Company’s GreenTherm™ Program and Rider G. The Commission granted the request but asked the Company to provide additional information regarding the avoided forest conversion project included in the GreenTherm™ Program’s portfolio of Green Attributes. Specifically, the Company was asked to provide the holder of the conservation easement and whether the conservation easement is term limited.

The avoided forest conversion project included in the Company’s Green Attribute portfolio consists of approximately 1,000 acres of forested land located in Washington and Hyde Counties of North Carolina. This project is subject to a permanent conservation easement with the United States Department of Agriculture to ensure that the land will not be disturbed by development.
