P1. <u>APPLICATIONS FOR CERTIFICATES OF PUBLIC CONVENIENCE AND NECESSITY TO CONSTRUCT SOLAR FACILITIES</u>

EXPLANATION: The following applications seek to renew certificates of public convenience and necessity for construction of solar photovoltaic (PV) electric generating facilities pursuant to N.C. Gen. Stat. § 62-110.1 and Commission Rule R8-64.

Duke Energy Progress, LLC:

- <u>Docket No. SP-7622</u>, <u>Sub 0</u> Application of Banner Solar, LLC, to amend and renew the certificate of public convenience and necessity to construct a 5-MW solar PV facility in Johnston County, North Carolina (registration statement issued previously).
- <u>Docket No. SP-7918, Sub 0</u> Application of Beckwith Solar, LLC, to renew the certificate of public convenience and necessity to construct a 5-MW solar PV facility in Columbus County, North Carolina (registration statement issued previously).
- <u>Docket No. SP-7932, Sub 0</u> Application of Selwyn Farm, LLC, to renew the certificate of public convenience and necessity to construct a 5-MW solar PV facility in Anson County, North Carolina (registration statement issued previously).
- <u>Docket No. SP-8189</u>, <u>Sub 0</u> Application of Aberdeen Farm, LLC, to amend and renew the certificate of public convenience and necessity to construct a 5-MW solar PV facility in Scotland County, North Carolina (registration statement issued previously).

The Public Staff has reviewed the applications and determined that they comply with the requirements of N.C.G.S. § 62-110.1 and Commission Rule R8-64.

RECOMMENDATION: (D. Williamson/Saillor) That the Commission issue orders approving the applications and issuing the requested amended and renewed certificates for the facilities. Proposed orders have been provided to the Commission Staff.

P1. DOCKET NO. W-218, SUB 526A - AQUA NORTH CAROLINA, INC. APPLICATIONS FOR APPROVAL TO IMPLEMENT SECONDARY WATER QUALITY SYSTEM IMPROVEMENT PROJECTS

EXPLANATION: On April 14, May 17, July 2, August 5, and August 20, 2021, Aqua North Carolina, Inc. (Aqua) filed Applications for Approval to Implement Secondary Water Quality System Improvement Projects Pursuant to N.C. Gen. Stat. § 62-133.12 and Commission Rule R7-39 (Applications). The six projects and the estimated costs are summarized below.

On August 30, 2021, the Public Staff – North Carolina Utilities Commission (Public Staff) filed its Report and Recommendations regarding Agua's Applications. The Public Staff stated that it had thoroughly reviewed the filter projects proposed by Agua and, based on its review of the Applications, the Public Staff determined that, for these projects, the filters are necessary for Aqua to provide adequate secondary standard water quality.

The Public Staff recommends that the Commission approve Aqua's implementation of the proposed secondary water quality projects.

EXHIBIT: A proposed order is attached as Exhibit No. P-1.

RECOMMENDATION: (Junis/Jost) That the Commission issue the proposed order authorizing Aqua to implement its six proposed filtration projects to comply with secondary water quality standards.

¹ In a discovery response provided to the Public Staff on March 23, 2021, the Company estimated that the interconnection of the Branston and Royal Senter Ridge distribution systems and separate filtration at Royal Senter Ridge Well 1 and Royal Senter Ridge Wells 2 and 3 would cost \$680,000.

P2. <u>DOCKET NO. W-354, SUB 391 – CAROLINA WATER SERVICE, INC. OF NORTH</u> CAROLINA – REQUEST FOR TARIFF REVISION

EXPLANATION: On July 28, 2021, Carolina Water Service, Inc. of North Carolina (CWSNC), filed a letter with the North Carolina Utilities Commission (Commission) pursuant to N.C. Gen. Stat. § 62-133.11, requesting authority to amend its tariff for the purpose of passing along to sewer customers in the Mt. Carmel service area in Buncombe County an increase in the cost of purchasing sewage treatment from the Metropolitan Sewerage District of Buncombe County (MSD). N.C.G.S. § 62-133.11(a) provides that the Commission shall allow a water or sewer utility to adjust its rates approved pursuant to N.C.G.S. § 62-133 to reflect changes in its costs based solely on changes in the rates imposed by third-party suppliers of purchased water or sewer service.

CWSNC states that MSD increased its usage charge for sewage treatment by \$0.19 per 1,000 gallons, increasing the rate from \$6.32 to \$6.51 per 1,000 gallons, and increased the monthly base facility charge by \$0.20 per sewer customer from \$7.29 to \$7.49. The change was effective on July 1, 2021.

The Public Staff – North Carolina Utilities Commission (Public Staff) has reviewed MSD's current rates and recommends that CWSNC's request for a tariff revision be approved.

The new rate would increase the average residential monthly sewer bill (< 1 inch meter) from \$65.15 to \$65.85, based on an average usage of 2,630 gallons. The average usage was determined in Exhibit 18 of the Testimony of Gina Y. Casselberry, Advanced Utilities Engineer, Public Staff Water, Sewer, and Telephone Division, filed on November 4, 2019, in Docket No. W-354, Sub 364.

RECOMMENDATION: (Casselberry/Henry/Magarira) That the proposed order be issued approving the recommended tariff revision.

P3. <u>DOCKET NO. W-354, SUB 392 – CAROLINA WATER SERVICE, INC. OF NORTH</u> CAROLINA – REQUEST FOR TARIFF REVISION

EXPLANATION: On July 28, 2021, Carolina Water Service, Inc. of North Carolina (CWSNC), filed a letter with the North Carolina Utilities Commission (Commission) pursuant to N.C. Gen. Stat. § 62-133.11, requesting authority to amend its tariff for the purpose of passing along to sewer customers in its College Park service area in Gaston County an increase in the cost of purchasing sewage treatment from the Town of Dallas. N.C.G.S. § 62-133.11(a) provides that the Commission shall allow a water or sewer utility to adjust its rates approved pursuant to N.C.G.S. § 62-133 to reflect changes in its costs based solely on changes in the rates imposed by third-party suppliers of purchased water or sewer service.

CWSNC states that the Town of Dallas increased its usage charge for sewage treatment by \$0.44 per 1,000 gallons, increasing the rate from \$7.33 to \$7.77 per 1,000 gallons. The change was effective on July 1, 2021.

The Public Staff – North Carolina Utilities Commission (Public Staff) has reviewed the Town of Dallas' current rates and recommends that CWSNC's request for a tariff revision be approved.

The new rate would increase the average residential monthly sewer bill (< 1 inch meter) from \$70.32 to \$72.06, based on an average usage of 3,967 gallons. The average usage was determined in Exhibit 18 of the Testimony of Gina Y. Casselberry, Advanced Utilities Engineer, Public Staff Water, Sewer, and Telephone Division, filed on November 4, 2019, in Docket No. W-354, Sub 364.

BY THE COMMISSION: N.C. Gen. Stat. § 62-133.12 authorizes the Commission in a general rate case proceeding to approve a rate adjustment mechanism to allow water and sewer utilities to recover the incremental depreciation expense and capital costs associated with reasonable and prudently incurred investments in eligible water and sewer system improvements. By Order issued May 2, 2014, in Docket No. W-218, Sub 363, the Commission approved Aqua North Carolina, Inc.'s (Aqua) request to utilize a Water System Improvement Charge/Sewer System Improvement Charge (WSIC/SSIC) mechanism pursuant to N.C.G.S. § 62-133.12, finding that the mechanism is in the public interest.

Commission Rules R7-39(f) and R10-26(f) provide that once WSIC/SSIC mechanisms are approved and eligible water and sewer system improvements are in service, the utility (in this case, Aqua) may file a request with the Commission for authority to impose water and sewer system improvement charges pursuant to the mechanisms.

N.C.G.S. § 62-133.12(c)(2) and (c)(4) provide, in pertinent part, that specific approval from the Commission is necessary before Aqua may undertake and recover its incremental depreciation expense and capital costs through the WSIC mechanism for eligible water system improvements implemented to comply with secondary drinking water standards.

On April 14, May 17, July 2, August 5, and August 20, 2021, Aqua filed applications for approval to implement secondary water quality system improvement projects pursuant to N.C.G.S. § 62-133.12 and Commission Rule R7-39 (Applications). The six projects and the estimated costs are summarized below.

On August 30, 2021, the Public Staff – North Carolina Utilities Commission (Public Staff) filed its Secondary Water Quality Report and Recommendations regarding Aqua's Applications. The Public Staff stated that it had reviewed the filter projects proposed by Aqua. Based upon its review of documents and other information provided by Aqua, site visits, and discussions with customers and Aqua's engineers and operations managers, the Public Staff recommended that the Commission approve the implementation of the proposed secondary water quality projects.

In recommending approval of the projects, the Public Staff advised that decisions to install filters, such as manganese dioxide filters, should be made judiciously because installing these filters is many times more costly than sequestration coupled with adequate flushing. According to the Public Staff, the annual revenue requirement increase for the minimum estimated capital expenditure of \$2,157,000 for these six filtration systems is approximately \$263,986 compared to the annual revenue requirement for the chemical cost for sequestration of approximately \$1,768. The Public Staff stated that the sequestration treatment of iron and manganese with polyphosphates and orthophosphates on water from North Carolina water wells, coupled with comprehensive water main flushing programs, has provided adequate secondary standard water quality on many water systems at a very reasonable cost. Testing to determine whether the iron and manganese are soluble (clear liquid) or insoluble (solid particles and visible) in raw untreated water at the well head, after treatment with polyphosphate/orthophosphate or SeaQuest® at the entry point, and in the distribution system, has been widely used in North Carolina for many years and provides extremely valuable information to assist in evaluations of whether filtration is necessary. These measures are exponentially less expensive than the installation of an iron and manganese filtration system.

¹ In a discovery response provided to the Public Staff on March 23, 2021, the Company estimated that the interconnection of the Branston and Royal Senter Ridge distribution systems and separate filtration at Royal Senter Ridge Well 1 and Royal Senter Ridge Wells 2 and 3 would cost \$680,000.

The Public Staff recognized, however, that for secondary water quality issues of considerable magnitude and consistency, sequestration treatment and flushing may not be effective and filtration may be necessary. As discussed in previous reports, the Public Staff strongly supports the implementation of two secondary water quality processes: a comprehensive customer education program and a comprehensive water main flushing program.

In summary, the Public Staff stated that it will continue to carefully and thoroughly review secondary water quality information and documentation presented by Aqua (including participating in meetings with Aqua engineers and operations managers), conduct selected site visits, discuss secondary water quality issues with customers, and, when appropriate, recommend Commission approval of equipment and infrastructure installations.

The Public Staff presented this matter to the Commission at its Staff Conference on September 7, 2021. The Public Staff stated that the proposed filters are necessary for Aqua to provide adequate secondary standard water quality and, as such, the Public Staff recommended that the Commission approve Aqua's proposed secondary water quality projects.

Based upon the foregoing, Aqua's Applications, the Public Staff's Secondary Water Quality Report and Recommendations regarding Aqua's Applications, and the entire record in this matter, the Commission finds and concludes that Aqua should proceed to implement secondary standard water quality improvements through the installation of Aqua's proposed filtration projects.

IT IS, THEREFORE, ORDERED that Aqua North Carolina, Inc., is authorized to implement the six filtration projects proposed in its April 14, May 17, July 2, August 5, and August 20, 2021, Applications to comply with secondary water quality standards.

BY THE COMMISSION: On July 28, 2021, Carolina Water Service, Inc. of North Carolina (CWSNC or Company), filed a letter with the North Carolina Utilities Commission (Commission) pursuant to N.C. Gen. Stat. § 62-133.11, requesting authority to amend its tariff for the purpose of passing along to sewer customers in the Mt. Camel service area in Buncombe County an increase in the cost of purchasing sewage treatment from the Metropolitan Sewerage District of Buncombe County (MSD). N.C.G.S. § 62-133.11(a) provides that the Commission shall allow a water or sewer utility to adjust its rates approved pursuant to N.C.G.S. § 62-133 to reflect changes in its costs based solely on changes in the rates imposed by third-party suppliers of purchased water or sewer service.

CWSNC stated that, effective July 1, 2021, MSD increased its usage charge for sewer service by \$0.19 per 1,000 gallons, increasing the rate from \$6.32 to \$6.51 per 1,000 gallons, and increased the monthly base facility charge by \$0.20 per sewer customer from \$7.29 to \$7.49. CWSNC requested to increase the commodity charge and the base facility charge applicable to its sewer customers in the Mt. Carmel service area for service rendered on and after the date of this order. The requested increase passes along the aforementioned increase in the cost of purchasing sewer service from MSD.

The Public Staff – North Carolina Utilities Commission (Public Staff) presented this matter at the Commission's Staff Conference on September 7, 2021. The Public Staff stated that (1) it has reviewed MSD's current rates and the Company's request and (2) recommended that the tariff revision be approved for service rendered on and after the date of this order. The Public Staff further stated that the new rates will increase the average residential monthly sewer bill (< 1 inch meter) from \$65.15 to \$65.85, based on an average usage of 2,630 gallons. The average usage was determined in Exhibit 18 of the Testimony of Gina Y. Casselberry, Advanced Utilities Engineer, Public Staff Water,

Sewer, and Telephone Division, filed on November 4, 2019, in Docket No. W-354, Sub 364.

Based upon the foregoing, the Commission concludes that the tariff revision should be approved.
