Members of the Utilities Commission:

We are North Carolina residents with rooftop solar on our house. The system was put into service in 2015 and has generated 70.4 MWh of energy since August 31, 2015, when we installed a monitoring system. In that same time period, our house consumed 98.8 MWh of energy, so our rooftop solar system has generated 71% of the energy our house consumed during that period. Our house is entirely electric (except for a propane BBQ grille and a propane fireplace on our porch) and, since 2019, we've owned an electric vehicle, which we charge in our garage except when we are traveling.

We tell you this so that you can understand that rooftop solar is not some sort of toy. Of course, not all homes are suitable for rooftop solar, but for those that are, rooftop solar can contribute significant amounts of the energy that a house consumes. This is energy that the utility does not have to invest in to generate. It is energy that does not worsen our growing and urgent climate crisis.

We invested in this system not because it made economic sense but because we wanted to do our part to help fight the climate crisis. Not everyone can do this, of course, but, since 2015, prices of rooftop solar have declined dramatically. The economics now make good sense and more and more people can afford to contribute to fighting the climate crisis in this way.

A crucial part of the economic story is net metering, which makes it possible for us to sell energy to the utility when others need it and we don't, and for us to purchase energy when we need it and the sun is not shining. If Duke's proposal is adopted, it will seriously disrupt the economics of implementing rooftop solar in NC, a state which, fortunately, has lots of sunshine. Moreover, since Duke seems averse to investing in utility-scale solar and wind as other large utilities are doing, Duke will need to build more fossil-fueled power generation facilities, causing us to worsen the climate crisis, not improve it.

Duke argues that they need to squash net metering because people like us don't contribute to maintenance of the grid. Hogwash. We pay a monthly fee to be connected to the grid, and our house uses less grid capacity than it would if we did not have rooftop solar. Moreover, because our excess power can flow to our neighbors who don't have rooftop solar, the demands on the long-distance transmission facilities of the grid are reduced.

Before you accept Duke's argument that poor people are subsidizing the grid for wealthier people who use rooftop solar, demand that their analysis, including the data that they use, be made public so that outside experts can scrutinize their methodology. Demand that their

analysis include a model of the effect on the grid of subsidizing rooftop solar for low-income people instead of investing in more gas-fired power plants.

We urge you to reject Duke's attempts to squash rooftop solar and instead require them to create a plan that encourages it.
