BY THE CHAIRMAN: On December 18, 2017, the Commission issued an Order Establishing General Rate Case, Suspending Rates, Scheduling Hearing, and Requiring Customer Notice in the above-captioned docket. Said Order stated that the hearing may be canceled and the matter decided on the filings if no significant protests were received on or before February 15, 2018.

On March 9, 2018, the Public Staff filed a Motion to Cancel Hearing. In said motion the Public Staff stated:

- 1. This proceeding commenced with the filing on December 4, 2017, of an Application for Rate Increase by MECO Utilities, Inc. In an order issued on December 18, 2017, the Commission scheduled a public hearing for 7 p.m., on March 22, 2018, in the Commission Hearing Room 2115, Dobbs Building, 430 North Salisbury Street, Raleigh, North Carolina. The hearing was scheduled subject to cancelation if no significant protests were received from consumers on or before February 15, 2018.
- 2. MECO Utilities, Inc. serves approximately 271 residential customers. By Certificate of Service filed December 21, 2017, MECO Utilities, Inc. stated that the Notice to Customers had been delivered to all affected customers. No consumer protests have been received.
- 3. The Public Staff has conducted its investigation and believes that an evidentiary hearing is not necessary. The Public Staff has not discovered any service problems. MECO Utilities, Inc. has agreed to the Public Staff recommended revenue requirements and rates.

Based upon the foregoing, the Chairman is of the opinion that the hearing scheduled for March 22, 2018, should be canceled, customer notice should be required, and a proposed order should be filed.

IT IS, THEREFORE, ORDERED as follows:

- 1. That the hearing previously scheduled for Thursday, March 22, 2018, at 7:00 p.m., in the Commission Hearing Room 2115, Dobbs Building, 430 North Salisbury Street, Raleigh, North Carolina is canceled.
- 2. That a copy of this Order shall be mailed with sufficient postage or hand delivered by MECO Utilities, Inc., to all customers in the above-captioned service area no later than two business days after the date of this Order, and that MECO Utilities, Inc. shall submit to the Commission the attached Certificate of Service properly signed and notarized no later than five business days after the date of this Order.
- 3. That the Public Staff shall file with the Commission a proposed order concerning the general rate increase application filed by MECO Utilities, Inc. on December 4, 2017.
- 4. That a further order of the Commission addressing the applied for rate increase shall be issued at a later date.
