ABD Farm Solar Project Description

Carolina Solar Energy II, LLC will design, permit, construct and commission a 6.50 MWdc (4.99MWac) photovoltaic generator to be located on approximately 40 acres of land at 3224 US 64 near the town of Asheboro, in Randolph County, NC at a cost of approximately \$15,500,000.

The project will sell electricity to Progress Energy Carolinas under a FERC avoided cost contract. The interconnection and delivery will be via Progress Energy Carolinas Power 3-phase service

The solar generator is composed of:

- 21,660 Canadian Solar 300 Wdc PV Panels
- Schletter FS Fixed tilt Ground Mount @ 25 degrees
- 6 x SMA 3 phase, 750kw Inverters
- Balance of System including wiring, combiner boxes, disconnects and hardware
- Remote monitoring system
- Security fencing
- Site area approximately 40 acres

Project Schedule

Carolina Solar Energy II, LLC proposes the following construction schedule:

- Design, financing and permitting Summer/Fall 2014
- Equipment delivery Spring 2015
- Generator construction Summer 2015
- Final inspections, commissioning and operation completed by December 31, 2015






