Notification of Sewer Moratorium Recission by the North Carolina

Department of Environmental Quality

Dear Ms. Dunston:

On July 22, 2022, the North Carolina Utilities Commission ("Commission") entered an Order in Docket No. W 1125, Subs 9 and 10 ("Order") with respect to Kinnakeet Shores Wastewater Treatment Plant ("WWTP"), which is owned by Outer Banks/Kinnakeet Associates, LLC ("OBKA"). The Order declared an emergency and directed the Public Staff to identify an emergency operator. This Order arose out of a hearing held on same day, in which homeowners' representatives appeared and joined the Public Staff to raise serious concerns about the existing Department of Environmental Quality ("DEQ") moratorium as well as "... the viability of the system and the threat of future failure of the WWTP that would affect residential sewer service and have a negative environmental impact." (Commission Order of July 22, 2022, page 2, re. testimony of Homeowners' Association President Pat Weston). The condition of the system was grave, prompting the following recitation by the Commission of the testimony of Public Staff witness Charles Junis1:

He testified that most crucial parts of the WWTP are not functioning at all or are not functioning properly, that many system components are being used to improperly store sludge, that the latest repair to the system failed within three days of installation of a replacement part, and that the system is releasing untreated wastewater directly into a storage/infiltration pond which is very likely impacting a nearby recreational pond. Witness Junis testified that the dilapidated condition of the WWTP posed a danger to operators and inspectors as well as a liability to the customers served by the WWTP. Witness Junis testified that the residents of Kinnakeet Shores are experiencing an actual loss of adequate service because of the condition of the WWTP and in his expert opinion, a real emergency exists necessitating the appointment of an emergency operator. Witness Junis also presented evidence that the Division of Water Resources (DWR) of the North Carolina Department of Environmental Quality (DEQ) has determined that the WWTP is non-compliant with the applicable permits. Specifically, the evidence presented by the Public Staff shows that on July 19, 2022, DWR found that wastewater is being pumped into the WWTP, that the WWTP is not treating the wastewater, and that effluent discharged from the WWTP will not meet permit limits.

The Public Staff also presented evidence that DEQ caused to be filed on May 5, 2022, in Dare County Superior Court a Complaint and Motion for Injunctive Relief, alleging, among other things, chronic neglect and mismanagement of the WWTP and requesting, among other things, that the Court direct OBKA to take specific and significant corrective action to comply with its permits. (Commission Order, page 2)

On August 3, 2022, the Commission appointed CWSNC Emergency Operator, and from then to now the Company has worked diligently, in productive cooperation with the Public Staff and DEQ, to make a host of corrections, changes, and improvements to this system. The Company is pleased to transmit to the Commission the attached letter of November 28, 2023, from DEQ Assistant Regional Supervisor Robert Tankard, which states that the conditions necessitating the imposition of the sewer moratorium on October 13, 2021, have been remediated. This has come about due to the work of CWSNC, and Mr. Tankard encourages the Company to continue its efforts to maintain and improve the wastewater treatment plant.

CWSNC State President Donald Denton wishes to convey his appreciation for the guidance and assistance of the Company's state regulators at the

Public Staff and DEQ, and to commend the diligent efforts of his Operations team in the remediation of the many problems at the Kinnakeet plant.

Dear Mr. Konsul:

On October 13, 2021, a sewer moratorium (with no new sewer taps, sewer extensions or additional flow) was placed on the Kinnakeet Shores' WWTP per the authority of North Carolina General Statute 143-215.67. Prior to that date, inspections conducted by the Division of Water Resources revealed severe deficiencies existed in areas of the operation and maintenance of the WWTP. As a result, the final effluent being discharged from the WWTP was undertreated, not meeting limits established in the permit, and threatening water quality. A determination was made that the WWTP could not adequately treat additional waste, and therefore the moratorium was imposed upon any new flow being introduced to the WWTP.

Since the time the moratorium was imposed, the Kinnakeet Shores' WWTP has been assigned an emergency operator, Carolina Water Service Inc. of North Carolina, by the North Carolina Utilities Commission. Inspections of the facility, as well as self-monitoring data reported by Carolina Water, have documented significant facility improvements and efforts in meeting permit conditions. Current performance at the WWTP indicates the conditions necessitating the imposition of the moratorium have been remediated, and the WWTP now has both the hydraulic and operational capacity to accommodate additional flow.



In light of these findings, the Division of Water Resources hereby removes the moratorium placed on the Kinnakeet Shores' WWTP. Carolina Water is encouraged to continue its efforts to maintain and improve the wastewater treatment plant as it endeavors to provide quality wastewater treatment services. Please be aware that should flow at the wastewater treatment plant exceed applicable design capacity thresholds as stated in 15A NCAC 02T.0118, or if the facility experiences an inability to treat additional waste, a moratorium could again be imposed.
