PUBLIC STAFF MOTION FOR
EXTENSION OF TIME IN
WHICH TO FILE TESTIMONY

NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission, by and through its Executive Director, Robert P. Gruber, and respectfully requests the Commission to enter an order in the above-captioned docket extending the time for filing intervenor testimony and exhibits from Wednesday, September 7, 2011, until Friday, September 9, 2011 and rebuttal testimony and exhibits from Friday September 16, 2011, until Tuesday, September 20, 2011.

In support of this motion, the Public Staff shows as follows:

1. On June 3, 2011, Carolina Power & Light Company, d/b/a Progress Energy Carolinas, Inc. (PEC), filed its application for approval of cost recovery of demand-side management and energy efficiency expenditures pursuant to G.S. 62-133.9 and Commission Rule R8-69. By Order issued June 8, 2011, the Commission set the matter for hearing on September 27, 2010, required the prefilings of direct testimony and exhibits of intervenors on or before Wednesday, September 7, 2011, and the prefilings of PEC's rebuttal testimony and exhibits on or before Friday, September 16, 2011.

2. Because of the press of work on a number of other matters, the Public Staff needs additional time in which to complete its investigation and prepare its testimony in this docket.

3. PEC and the Carolina Utility Customers Association, Inc. have indicated to the Public Staff that they have no objection to the extension for the filing of intervenor and rebuttal testimony and exhibits requested in this motion.

Therefore, the Public Staff moves

(1) that the time for filing direct testimony and exhibits of intervenors be extended from Wednesday, September 7, 2011 to Friday, September 9, 2011;
